On 2/5/18 at approximately 1325 hours I was dispatched to 557 Merrimac, Ter. Apt D in unincorporated west palm beach (Palm Beach County FL) to investigate the report of an assault. Dispatch advised complainant said just threw her into coffee table and left.

On arrival I met with Arthur Barton who said he was in an argument with his girlfriend, Diana Neeman, about her wanting him to move out, when she started hitting him in the face and head and then pushed him into a coffee table. Barton said he didn't hit her back. I saw a red mark under Barton eye and a bloody laceration on his back. I asked if anyone else witnessed incident and he said no.

I then spoke with Diana Neeman who was crying and appeared intoxicated. Neeman said she was arguing with Barton to leave and he hit her in the head and arms then pushed her into the coffee table. Neeman had no visible marks or injury where she said Barton hit her. Neeman had a bloody laceration on her inside left thigh and left calf. Neeman was asked three times by D/S Izzarone if anyone saw incident and she said no. I saw a broken coffee table in the living room with broken glass spread on floor.

On scene a male arrived, Wilfredo Ferreira who said the girl didn't do anything don't arrest her. I asked if he seen what happened and he said no, then he said yes. He then said he was in the process of having him evicted. I asked if he seen the smashed coffee table when he was here and he said no. D/S Taylor confirmed Ferreira was not here during incident and returned to residence after incident. Both parties refused treatment at the seen for their injuries.

Bartons back injury looked to be caused by being pushed onto table and breaking glass. Neewman cuts were on the inside of her leg which would appear to happen after glass was broken. Based on the lack of an independent witness, the lack of injuries to Neewman where she said she was punched by Barton, the laceration on Bartons back and injury to his eye which were consistent with being hit in the face and being pushed into a table landing on his back, I find Probable Cause to Charge Neewman with Battery. FSS 784.03
