DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

While on another traffic stop I observed Lee's vehicle run the red light at US 1 and Beach Rd. the vehicle stopped in the intersection. Sgt. Blanc who was behind Lee's vehicle initiated a traffic stop for multiple traffic offenses including failure to maintain single lane, driving on a marked bike path and violation of traffic control device. The vehicle came to stop on Beach Rd. at the entrance to Lighthouse Park in the right turn bay.

OBSERVATION OF DRIVER:

I approached the vehicle on the passengers side of the vehicle. I asked Lee to roll the window down and she was not able to find the window control button. She first unlocked the vehicle using a button on the drivers side door, then she looked in the middle counsel and found the window control button and lowered the window. Lee was slurring her speech and was confused on why she was pulled over. Lee was asked to step out of the vehicle and had to balance herself using her vehicle. Lee started to sway from left to right as she was standing stationary, repeatedly switching her weight between her feet. While I was giving instructions to Lee, she began to sway front to back by moving her weight to the balls of her feet and catching herself from falling forward.

DRIVER'S STATEMENTS:

Lee repeatedly asked me to call JICPD Ofc. Mathews and repeatedly asked me why she was stopped, each time the reason for the stop was explained again.

ODORS:

Odor of an unknown alcoholic beverage emanating from her person and her breath.

GENERAL OBSERVATIONS

SPEECH: confusing speech, repetitive, and slurred.

ATTITUDE: Sleepy, confused, mood changes between cooperative, polite and belligerent.

CLOTHING: Blue dress and brown sandals

MEDICAL/OTHER: Past knee injury, past neck injury and past collar bone injury.

Lee conducted eleven steps forward and failed to make a controlled turn. Upon return Lee failed to walk heel to toe, repeatedly stepped of the line, and completed eleven steps. On her last step Lee did a small dance raising her hands in celebration.

ONE LEG STAND:

Lee was unable to stand with one leg raised, repeatedly setting her foot down and raising it less then six inches. During subsequent restarts Lee repeatedly hopped to maintain her balance. After almost falling the task was discontinued.

FINGER TO NOSE:
