BEHIND WHEEL OF VEHIND While on another traffic stop I observed Lee's vehicle run the red light at US 1 and Beach Rd. the vehicle stopped in the intersection. Sgt. Blanc who was behind Lee's vehicle initiated a traffic stop for multiple traffic offenses including failure to maintain single lane, driving on a marked bike path and violation of traffic control device. The vehicle came to stop on Beach Rd. at the entrance to Lighthouse Park in the right turn bay.	ffic
OBSERVATION OF DRIVER:	
I approached the vehicle on the passengers side of the vehicle. I asked Lee to roll the window down and she we not able to find the window control button. She first unlocked the vehicle using a button on the drivers side door, then she looked in the middle counsel and found the window control button and lowered the window. I was slurring her speech and was confused on why she was pulled over. Lee was asked to step out of the vehicle and had to balance herself using her vehicle. Lee started to sway from left to right as she was standing stationary, repeatedly switching her weight between her feet. While I was giving instructions to Lee, she began to sway front to back by moving her weight to the balls of her feet and catching herself from falling forward.	ee e
