VI. <u>DETAILS OF DUI/BUI</u>

A. Phase 1 - Initial Observation of vessel in operation

On Thursday, July 4, 2019 at approximately 1815 hours, I, Officer James Brodbeck of the Florida Fish and Wildlife Conservation Commission, was on vessel patrol near Peanut Island, Palm Beach County. South of the Blue Heron Blvd. Bridge, I observed a black and blue PWC violating the Slow Speed/Minimum Wake zone. The vessel was operating with its bow in the air, throwing a substantial wake. The vessel also had registration numbers which were less than 3 inches without proper spacing. A vessel stop was initiated to address the violations.

B. Phase 2 - Personal Contact with driver/operator of vehicle/vessel

Upon making contact with the operator, identified by name and DOB as DIANNY BETANCOURT, I observed that he was very sunburned and had glassy, bloodshot eyes. When asked for the vessel registration, he handed me the registration for a different vessel. I asked BETANCOURT if he would complete Standardized Seated Field Sobriety Tasks, and he agreed.

C. Phase 3- Pre-arrest screening and Observations of Driver/Operator

HGN: During Horizontal Gaze Nystagmus, BETANCOURT displayed a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and an onset of nystagmus prior to 45 degrees in both eyes.

FTN: During Finger to Nose, Performance Stage, BETANCOURT kept moving his head forward and had to be reminded to keep his head tilted back. On the first left, BETANCOURT hesitated, used the pad of the finger, and missed the tip of the nose. On the first right, BETANCOURT searched for the tip of the nose, missed the tip of the nose, and did not bring his hand down

immediately as instructed. On the second right, BETANCOURT did not bring his hand back down as instructed. On the third left, BETANCOURT searched for the tip of the nose and missed the tip of the nose.

PP: During Palm Pat, BETANCOURT had numerous chopped pats, not making proper contact.

HC: During Hand Coordination, Performance Stage, BETANCOURT counted from 1 to 4 twice. On Task 3, BETANCOURT only counted to 7, and did not return his left fist to his chest.

D. Arrest of Operator

At 1822 hours, I placed BETANCOURT under arrest for suspicion of BUI. At Phil Foster Park, BETANCOURT refused to provide a URINE sample after being read implied consent and being provided the opportunity to provide a sample. I charged BETANCOURT with the following violations:

F.S. 327.35(1)(a)- BUI Normal Faculties Impaired

F.S. 327.35215(1)- Refusal to submit to submit to Urine Test pursuant to 327.352

E. Disposition of Operator and vessel

BETANCOURT was turned over to the Palm Beach County Sheriff's Office for transport to the Palm Beach County Jail, Main Detention Center. The vessel was turned over to its registered owner.



VI. <u>DETAILS OF BUI</u>

A. Phase 1 - Initial Observation of vessel in operation

On Thursday, July 4, 2019 at approximately 1815 hours, I, Officer James Brodbeck of the Florida Fish and Wildlife Conservation Commission, was on vessel patrol near Peanut Island, Palm Beach County. South of the Blue Heron Blvd. Bridge, I observed a black and blue PWC violating the Slow Speed/Minimum Wake zone. The vessel was operating with its bow in the air, throwing a substantial wake. The vessel also had registration numbers which were less than 3 inches without proper spacing. A vessel stop was initiated to address the violations.

B. Phase 2 - Personal Contact with operator of vessel

Upon making contact with the operator, identified by name and DOB as DIANNY BETANCOURT, I observed that he was very sunburned and had glassy, bloodshot eyes. When asked for the vessel registration, he handed me the registration for a different vessel. BETANCOURT seemed unsure of who was operating the other PWC he was with or where she had gone. I asked BETANCOURT if he would complete Standardized Seated Field Sobriety Tasks, and he agreed.

C. Phase 3- Pre-arrest screening and Observations of Operator

HGN: During Horizontal Gaze Nystagmus, BETANCOURT displayed a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and an onset of nystagmus prior to 45 degrees in both eyes.

FTN: During Finger to Nose, Performance Stage, BETANCOURT kept moving his head forward and had to be reminded to keep his head tilted back. On the first left, BETANCOURT hesitated, used the pad of the finger, and missed the tip of the nose. On the first right, BETANCOURT searched for the tip of the nose, missed the tip of the nose, and did not bring his hand down immediately as instructed. On the second right, BETANCOURT did not bring his hand back down as instructed. On the third right, BETANCOURT used his left hand. On the third left, BETANCOURT used the right hand, searched for the tip of the nose and missed the tip of the nose.

PP: During Palm Pat, BETANCOURT stopped the task before being told to do so.

HC: During Hand Coordination, Performance Stage, BETANCOURT counted from 1 to 4 twice. On Task 3, BETANCOURT only counted to 7, and did not return his left fist to his chest.

D. Arrest of Operator

At 1822 hours, I placed BETANCOURT under arrest for suspicion of BUI. Due to not detecting any odor of an alcoholic beverage, I requested breath as well as urine samples. At Phil Foster Park, BETANCOURT refused to provide a URINE sample after being read implied consent and being provided the opportunity to provide a sample. I gave BETANCOURT approximately 3 minutes to

E. Disposition of Operator and vessel

BETANCOURT was transported by vessel and vehicle to the Palm Beach County Jail, Main Detention Center. The vessel was turned over to its registered owner at Phil Foster Park.
