

CAN NOT DO, WHY? \_\_\_\_\_

WALK AND TURN:

DURING THE INSTRUCTIONAL PHASE, WEBER HAD DIFFICULTY KEEPING HIS HANDS AT HIS SIDE HE KEPT PLACING THEM BEHIND HIS BACK, AND HE DID NOT PUT HIS RIGHT FOOT AHEAD OF HIS LEFT FOOT WHEN INSTRUCTED. DURING MY DEMONSTRATION I ASKED WEBER IF HE UNDERSTOOD THE TASK, HE RESPONDED "YES" WHEN HE WAS INSTRUCTED TO BEGIN HE COULD NOT PERFORM ANY OF THE HEEL TO TOE STEPS AS DEMONSTRATED. AT THE END OF THE 9TH STEP, WEBER DID NOT TURN AS DEMONSTRATED AND PERFORMED AN ABOUT FACE. HE WALKED BACK TO THE STARTING POINT WITHOUT COUNTING HIS STEPS OR PERFORMING ANY OF THE HEEL TO TOE STEPS.

ONE LEG STAND:

WEBER RAISED BOTH ARMS MORE THAN 5 INCHES FROM HIS SIDE AND HE COULD NOT MAINTAIN HIS BALANCE AS INSTRUCTED. WEBER RAISED HIS RIGHT FOOT MORE THAN 6 INCHES AND DID NOT FOCUS ON HIS ELEVATED FOOT AS INSTRUCTED. WEBER HOPPED 2 TIMES TO MAINTAIN HIS BALANCE AND PLACED HIS FOOT DOWN BEFORE BEING INSTRUCTED TO STOP. HE STOPPED HIS COUNT AT 1008.

FINGER TO NOSE:

AFTER THE DEMONSTRATION, WEBER CLOSED HIS EYES AND SWAYED FROM SIDE TO SIDE. ON HIS FIRST ATTEMPT TO TOUCH THE TIP OF HIS NOSE HE PLACED HIS RIGHT POINTER FINGER ON THE BRIDGE OF HIS NOSE. ON THE SECOND ATTEMPT HE PLACE THE PAD OF HIS LEFT POINTER FINGER ON THE BOTTOM SIDE OF HIS NOSE. HE ALSO NEEDED TO BE TOLD TO PLACE HIS HANDS BACK TO HIS SIDES ON 2 OCCASIONS.



Additionally, if you refuse to submit to the test I have requested of you and if your driving privilege has been previously suspended for a prior refusal to submit to a lawful test of your breath, urine or blood, you will be committing a misdemeanor. Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
