


<p>On Friday 2-17-2017, at approximately 2305 hours, I was dispatched to 131 S Federal Hwy apartment 123 in reference to a physical domestic. Upon arrival, I could hear a male and female inside the apartment yelling at each other.</p> <p>I met with the occupants George A Patti, Dijon Surico, and George P Patti (father) in apartment 132. I first spoke with Dijon who advised that she and her boyfriend, George A, went out to dinner and when they came home they got into a verbal argument. Dijon stated that when they got into the apartment George A was talking on the phone with another girl. Dijon stated they began yelling at each other at which time George A pushed her into the bedroom then into the bathroom and finally struck her in the face. It should be noted there were no marks on Dijon's face which would indicate she was struck or punched. Dijon could not provide any compelling details on how she was struck (open hand, closed hand, right, or left). Dijon advised she grabbed a golf club that was in the bedroom, struck George A in the living room with it and then called BRPD. Dijon advised they continued to yell at each other until police arrived. It should be noted that Dijon was very intoxicated and parts of her story kept changing.</p> <p>Next, I spoke with George A Patti who confirmed they were out to dinner and had multiple drinks. George A advised when they got back to his apartment at the Camden, Dijon went inside while he stayed outside to talk with his ex-wife on his cell phone. George A stated Dijon came outside and began yelling and swung at him as to hit the cell phone from his hand. At that time she made contact with the side of his head and the cell phone. George A advised the phone dropped to the ground and he picked it up and went inside while he was still on the cell phone. George A advised when he went inside, Dijon was screaming at him and he began to yell back. George A then stated she slapped the phone out of his hands again causing the phone to fall to the floor. George A stated that he bent over to pick up his phone and as he did Dijon struck him repeatedly with a golf club which she got from the bedroom on his arm, shoulder, and back. George advised while he was getting hit from behind his father, George P, came out of his bedroom and tried to stop her from striking him. George A advised he reached back and grabbed Dijon's dress (in hopes she would stop striking him) causing her to fall on top of him and then to the floor. Extremely upset of the situation and the fact that he had been struck with a golf club George A advised he yelled at Dijon to leave the apartment and she called the police. George A advised at no time did he put his hands on Dijon or intentionally strike her.</p> <p>Lastly, I spoke with George P Patti who advised he was sleeping and was awoken by screaming, yelling and banging in the living room. George P advised when he exited his bedroom he observed Dijon repeatedly striking his son, George A, from behind. George P stated that he stepped attempted to stop her from striking George A by grabbing the golf club. George P advised they continued to yell at each other but did not observe any other physical interactions.</p> <p>It should be noted that George A had lacerations to his elbow and bruising on his left arm from being struck with the golf club. Photos of George were placed into evidence.</p> <p>Based on my investigation and the physical evidence, Dijon Surico was placed under arrest at 0033 hours pursuant to FSS 784.045(1a) aggravated battery (domestic) after she slapped her boyfriend in the side of the head and subsequently struck him repeatedly with a golf club causing abrasions and bruising to his arm, back and side. Dijon Surico was turned over to Palm Beach County Jail for processing.</p> <p>Statements were submitted into evidence and George A refused the domestic pamphlet.</p>
