<p>On 11/06/2016, at approximately 1830 hours, I was dispatched to a battery that just occurred at Edna Hibel and University Boulevard (Italian festival). Upon arrival all parties were separated, and I spoke to the victim, H/M Javier Perez (03/22/1992), who advised the following:</p> <p>He advised a customer, W/M Dominick Manzo (06/20/1971), walked to his booth (Rineland Cutlery) at Italian festival and purchased a 20 piece set of knives, also included an 8" cleaver, a wine bottle opener and a knife sharpener. Perez stated Manzo advised him that he would come back at the end of the festival and pick up his products. Perez advised when the suspect returned to pick up his products he seemed intoxicated and started to demand for Perez to give him a cutting board that he thought he paid for. At this time, Manzo started to dispute and argue with Perez about the things he bought. Manzo then flipped the table at Perez's booth which had his entire product on it. The items on the table were thrown to the ground, causing them hit the concrete which damaged the product. Perez then ran to the other side of the table to confront Manzo about what just happened and call the police.</p> <p>While Perez was on the other side of the table to call the police, Manzo's daughter's boyfriend (W/M Bruce Caldwell 02/16/1998) ran over the table and tackled Perez. I did not observe any injuries on Perez, and Perez declined medical attention on scene. Perez stated he wants to prosecute for the battery. At that point of the investigation I had probable cause to arrest Caldwell with simple battery. Caldwell was released on his own recognizance with a Notice to Appear.</p> <p>The two witnesses, W/F Dawn DeRossa (08/26/1971), and W/M James Gaddis (06/26/1981), observed the altercation and stated they saw Manzo and Perez in a verbal altercation about the items he purchased. They advised they saw Manzo flip the table and Perez coming from behind the table to confront Manzo, when Caldwell tackled him to the ground.</p>



Based on my investigation I found probable cause to charge Dominick Manzo with criminal mischief because he did unlawfully, willfully and maliciously, injure or damage, or place graffiti thereon or commit an act of vandalism to culinary knives, the property of Javier Perez, such damage being more than one thousand (\$1,000.00) dollars, contrary to Florida Statute 806.13(1) (a) and (b)3.
