On the 25 day of May, 2018 at 22:54 (Specifically include facts constituting cause for arrest)

On Friday, May 25th, 2018, at 2254hrs, I, Ofc. Jonathan Sanchez was patrolling the area of N Military Trl and Elm Ave in Palm Beach Gardens, FL. My body worn camera was used. While in my marked Palm Beach Gardens Police vehicle I observed a black vehicle bearing FL tag WH68F southbound on N Military Trl, passing multiple moving vehicles including my vehicle at a high rate of speed. Due to the wet road conditions because of heavy rain and the disregard for traffic safety, I initiated a traffic stop for careless driving.

Once stopped I approached the vehicle on the driver's side. The driver, later identified as Donald Ehrler (W/M 01/18/91), lowered the window. He was advised of the reason for the traffic stop. Ehrler's driver's license and tags were run through NCIC/FCIC. Ehrler was advised he was given a written warning in reference to careless driving. I returned Ehrler's documentation to him and asked if I could search his vehicle. Ehrler advised it was okay for me to search his vehicle. While searching the vehicle, one green rubber container and one gray container containing suspected marijuana oil were located in the cupholder between the driver's seat and the passenger's seat. Ehrler was read his Miranda Warnings from a printed card. I asked Ehrler what was inside of the containers and he stated he did not know and the containers were not his however based on the location, it is found to be readily accessible to him. Ehrler was placed into handcuffs. The handcuffs were checked for proper fit and double locked for safety.

Due to the congealed state of the suspected marijuana oil, I was unable to remove the substance from the container to weigh it. The green container weighed 23.8g and the gray container weighed 12.3g. The suspected marijuana, approximate weight 1.5g, was tested using a 908 Duquenois-Levine Reagent test kit which exhibited positive results for THC.

Probable cause exists to charge Donald Ehrler with 1 count of felony possession of marijuana oil. Ehrler was in constructive possession of suspected marijuana oil contrary to FSS 893.13(6)(A).
