D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The observation of the driving pattern, and the initial contact with the driver, was conducted by Sgt. Robert Piantoni ID#270, and the following statement was made by him. "On 10/20/17, at approximately 11:08 PM, while on routine patrol at the 14200 block of US Hwy 1, Juno Beach, Palm Beach County, FL I noticed a vehicle traveling in the south bound lanes in the north bound direction. The vehicle was a white Mercedes with Florida tag 853QAE. I remained in the north bound lanes of US Hwy 1 and activated my emergency lights and siren to get the drivers attention. At approximately the 14500 Block of US Hwy 1 I was ahead of the vehicle and I stopped in a turn lane. The vehicle made an abrupt right hand turn striking the curb that sent the front end of the vehicle in the air. The driver recovered and then entered the turn lane area to cross back over to the north bound side of the road. The vehicle came to a stop just south of Ocean Royale Way. I made contact with the driver and I could immediately smell an odor of an unknown alcoholic beverage. I asked the driver for his license, registration and insurance which he provided. The driver advised he had two drinks and dinner at a local restaurant called Nick and Jonny's. His speech was also slightly slurred. Due to the indication that the driver might be impaired the investigation as turned over to Officer Isham."

OBSERVATION OF DRIVER:

Driver was identified by FL DL as Donald E. Morin. Morin had bloodshot watery eyes, and his eyes appeared to only open halfway, he later stated this was a medical issue. When I requested the driver exit the vehicle, I noticed that his movements were very slow and he had to lean against the vehicle to get out. Morin swayed while walking from the vehicle to the nearby sidewalk.

DRIVER'S STATEMENTS:

Morin's speech was slow and slurred, and sometimes repetitive. Morin stated he had 2 beers at Nick and Johnny's Restaurant. He also stated that he knew he was driving on the wrong side of the road when he pulled out, but was unable to get back on the right side of the road. When I asked him where he was going, he said home, which he said was near Prosperity Farms Rd in North Palm Beach. When I told him that he was traveling the wrong direction, and that he needed to go South, he said that he accidentally made a left out of the plaza when he was supposed to turn right. He also said he had muscular dystrophy and that it affected his ability to walk heel to toe. While at the BAT, Morin argued that he had not gone the wrong direction to his house, even though he admitted he did on scene. He also admitted he had a Vodka and club soda at home before dinner.

ODORS:

Very strong odor of an unknown alcoholic beverage was being emitted from driver's breath and person as well as from the vehicle's interior.
