# D.U.I. PROBABLE CAUSE AFFIDAVIT

**PERSONAL CONTACT**

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

Off-duty City of Boynton Beach Police Officer Malley (ID 949) observed while in the area of PGA Blvd. and Interstate 95 a white 2013 Toyota Prius (FL tag ELITESA) occupied by driver and sole occupant Dusko Piljic. Piljic stated that he lost control when exiting the off-ramp from northbound Interstate 95 to head eastbound on PGA Blvd. and did not know what occurred prior to resulting in the crash. According to fresh skid marks leading up to Piljic's vehicle it appeared that the vehicle proceeded to cross all eastbound lanes of traffic, struck and went over a raised median, crossed westbound traffic lanes, then came to a final rest in the swale area on the north side of the westbound lanes.

## OBSERVATION OF DRIVER:

Dusko Piljic had glassy eyes, was slightly unsteady on his feet, and talkative during contact. He was swaying during Standardized Field Sobriety Tasks and raised his arms for balance during tasks, and had difficulty in retaining instructions of the tasks.

## DRIVER'S STATEMENTS:

Post Miranda Warning Piljic stated that he was at Cheetah's, a West Palm Beach-based adult nightclub, where he consumed two beers approximately one hour ago prior to driving.

## ODORS:

Discernible odor of an unknown alcoholic beverage.



Other Observations:WALK & TURN:

Piljic stated that he understood the instructions and began with the wrong foot and stepped off the line in the initial walk, counted nine (9) twice and took an extra step, did not leave front foot planted during turn phase, and proceeded to perform the return walk with the wrong foot forward. During the fourth (4) return step he raised his arms greater than six inches to assist in balance, again on the sixth (6) step, then proceeded to take ten (10) steps contrary to the instructed nine.

ONE LEG STAND:

Piljic stated that he understood the instructions and began this task by lifting his right foot off the ground. Dropped his foot after the first count, used his arms for balance greater than six inches, and upon reaching the second set of counting in tens he repeated four (4) and six (6) each twice. Piljic then hopped during the seventh (7) count and continued to use his arms for balance.

FINGER TO NOSE:

Piljic began to perform this task during the instructional phase. He stated that he understood the instructions and began this task. Aside from instructing him to put his arm down each time Piljic performed this task without apparent issue.

ROMBERG/ALPHABET:


Piljic stated that he holds a Bachelor's Degree from a university in Croatia and that he knows the alphabet A to Z. Piljic began this task and upon reaching letter G, proceeded to recite F-Q-R-F-Q-R then began to recite the alphabet in a foreign language. This task was not completed in full by Piljic.
