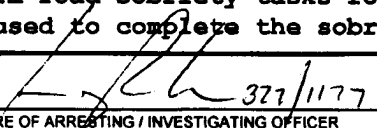

On 10/05/2019 at approximately 0146 hours I was on a traffic stop on S Alt A1A. I had a vehicle pulled over in the southbound outside lane just north of Frederick Small Rd with my emergency lights on. I observed a white SUV drive by in the center lane, the lane closest to where I had a vehicle pulled over. The white SUV failed to slow down or move over to the furthest lane away from the traffic stop. I immediately got into my patrol vehicle and followed the white SUV as it made a right turn onto westbound Frederick Small Rd. I called out the vehicles information, it was a white SUV bearing FL tag 575PID, to dispatch. Once I got a reply with the vehicles information I activated my lights and sirens as the vehicle turned onto southbound Military Trl. The vehicle came to stop in the outside lane just south of Frederick Small Rd. I approached the vehicle on the driver side making contact with the driver who was later identified as Dustin B Juhasz (W/M 04/18/1980). I explained to Juhasz why I pulled him over. Juhasz stated that he never heard of the move over law. As Juhasz spoke to me I detected an odor of an unknown alcoholic substance on his breath as he spoke. I observed Juhasz had glassy eyes. Juhasz told me that they were coming from a friend's home and denied having something to drink this evening. I asked Juhasz for his registration and proof of insurance. I watched as Juhasz grabbed both of the documents. Juhasz dropped his insurance card and only handed me his registration. I had to Juhasz again for his insurance card. I eventually asked Juhasz to step out of the vehicle. At first Juhasz refused to step out of vehicle, but after asking him more firmly he decided to step out. As Juhasz got out of his vehicle I observed him sway from right to left as he walked to the rear of his vehicle. I asked Juhasz if he was willing to perform road sobriety tasks for me. Juhasz became argumentative once more and at first refused to complete the sobriety

tasks. I explained the Taylor Warning to Juhasz and asked him again if he was willing to perform the sobriety tasks. Juhasz agreed.

For the HGN Juhasz showed lack of smooth pursuit in both eyes, he showed distinct and sustained nystagmus at maximum deviation in both eyes and he showed onset of nystagmus prior to 45 degrees in both eyes. For the Walk and Turn Juhasz lost his balance during the instruction stage, he made an improper turn and he was unable to touch heel to toe on several steps. For the One Leg Stand Juhasz swayed while in place, he placed his foot on the ground. For the finger to nose touch Juhasz did the following; L1 the pad of his finger to the top of his nose, and he did not return arm to side. R1, he touched the pad of his finger to the top of nose. L2, he touched the pad of his finger to his nose. R2, he touched the pad of his finger to the top of his. R3, he touched the pad of his finger to the top of his nose. L3, he touched the pad of his finger to the top of his nose. For the Romberg alphabet he recited the entire alphabet correctly.

Upon completion of the roadside tasks, I placed Juhasz under arrest for DUI and informed him. I secured Juhasz in handcuffs, which I checked for spacing and double locked. I placed Juhasz in the back of my police car.

I then transported Juhasz to the Palm Beach County Breath Alcohol Testing Facility. I conducted a 20-minute observation period to ensure that Juhasz did not take anything by mouth or regurgitate. I then requested Juhasz provide a sample of his breath. He refused immediately. I then read implied consent to Juhasz from a prepared text, and he refused a second time. I read Juhasz his Miranda Rights from a prepared text. Juhasz answered questions from a prepared questionnaire. I secured Juhasz in a holding cell and completed my paperwork. I subsequently booked Juhasz into the Palm Beach County Jail where I charged him with DUI FSS 316.193(1). My axon body warn camera was utilized.

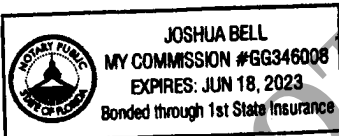
