Carrie was in the room with Stacie Rainey (w/f 4/1/78). Carrie stated her and Stacie went out last night. Carrie stated she slept over Stacie's house 1100 Via Royale (112). Carrie stated Stacie's boyfriend Dustin Gallo (w/m 3/20/86) had arrived home from hunting in Georgia at 1000 hours. Carrie stated he came into his and Stacie's room and pulled her off the bed and slammed her into the wall. Carrie gave her statement on BWC. Carrie stated she wanted to press charges I spoke to Stacie, she stated they (Carrie and her), were in her bed sleeping. Stacie stated bustin grab Carrie out of the bed, slamming her into the wall. Stacie stated Dustin grabbed his clothes and went to his mother's house. Stacie stated Dustin's mother lived in Boyton Beach. BWC Utilized I phoned Dustin via Northcom on a recorded line. I asked Dustin to come to the department to give his statement. Dustin stated he would come in tomorrow. Dustin advised he was in Boyton Beach. The hospital gave Carrie stitches to the laceration over her left eye, photos taken of before and after. Through my investigation I found Dustin Gallo's actions, Intentionally caused a laceration on Carrie Jorgenson's face above her left eye. The injury is considered a permanent disfigurement to Carrie Jorgenson face per FSS. 784.045 (1)(a).
