On 9/24/2019 at approximately 1925 hours I responded to 12079 189th Ct N in unincorporated Jupiter FL 33458 in reference to a Written statements to kill. Upon arrival I met with Tiffany Kuhn who advised earlier this evening at around 1700 hours her friend W/M Dusty Minnier gave her a ride to Lake Park Walmart to get a new tire. Tiffany advised Dusty paid for the tire with his card upon check out. When they got back to her house she paid him the money she owed for the tire and Dusty then handed Tiffany a total amount of \$40.00 cash. Prior to Dusty leaving, he was asking Tiffany if she would spend the night over at his house, to which she declined in doing so. After he was turned down he became very angry and began making threats towards her and her family. At a later time that day she stepped out for dinner and while she was away she was informed that Dusty showed up to her house and made further threats to her family. It should be noted no physical contact was made during that time as he left the area. After having him come by the house unannounced they decided to have Palm Beach County Sheriffs Department to respond.

While speaking with Tiffany she showed me multiple messages on her cell phone via facebook messenger from Dusty Minnier. It should be noted the messages included a picture of Dusty Minnier with his name attached providing it was from his device. Tiffany advised he was a family friend for a while and dated him when she was 15. She then provided me with his current address of 13433 154th Place N Jupiter FL 33478, phone number and vehicle descriptions that are in his driveway. The vehicle description are as follows: Orange 1972 Chevrolet Pickup Truck Tag#IG9012 and a 2012 White Ford work van Tag#EEDV50. The text messages he sent stated he would be "Running up in their house knocking them out and taking what he wants", "If I catch you outside the house im going to beat everyone of your fucking ass's" "I'll come over there and pistol whip the shit out of you" "Im paying a Niger \$100.00 im going to finish it tonight late night" "You think im playing, im a nasty motherfucker" "Im just warning you if it comes to the middle of the night its going to be a real nasty fucking situation over there cuz it'll be six of us coming in every window in the house" "You do realize that Chevelle truck just made it to gun play tonight I aint fucking with yall I dont give a fuck how many people in there my black homeboy will run up in your house and take care of yall Test me". Following those messages he sent a picture of two hand guns, a Rifle, shotgun, brace knuckles and a baseball bat laid on the floor. Tiffany was then advised to block any messages from Dusty to which she stated she would be staying at her boyfriends house and her mother and father would be going to the hospital due to her father feeling ill.

I provided Tiffany with a Victim case information form and a written sworn statement for her to fill out. I advised her I would be going over to Dusty's residence in attempt to make contact with him to get his side of the story. Upon arrival to Dusty's residence, I observed the two vehicles Tiffany described which both came back to him. The residence was gated so I was unable to make entry, I then proceeded to make contact with him via land line to which I was greeted with him answering the phone "Dusty!" I then advised the following response: "This is D/S Germano with the Palm Beach County Sheriffs Office Im trying to speak with Dusty". He then responded "Thats great have a good night!" and hung up the phone. I then returned back to Tiffany's to advise her I did not make contact with him and retrieved her completed written sworn statement. Prior to leaving I had Tiffany screen shot the messages and forward them to my email to be placed into evidence. Tiffany was informed on the following charges that will be filed with the state attorney.

Based on my investigation I find probable cause to arrest Dusty J Minnier for Written Threats to Kill under F.S.S. 836.10(1)
