





	<p>medication and threatened to throw it away. Dymphna stated she then grabbed her Stun Gun (Monster 18M) and told Jeffrey to give her back her medication. Dymphna advised she pointed the Stun Gun at Jeffrey and turned it on once. Dymphna stated Jeffrey grabbed a CD case and attempted to swing the CD case at her. Dymphna then said Jeffrey ran and grabbed a Swiffer mop stick and struck her on the wrists and chest with it. I observed Dymphna's wrists and did not see any visible injuries. Dymphna stated she still had the Stun Gun in her hand at the time. According to Dymphna, Jeffrey then grabbed the trash can bin and threatened to hit her with it. Dymphna advised Jeffrey called 911 shortly after.</p> <p>I then met with Jeffrey who advised he started arguing with Dymphna over their daughter's singing lessons. Jeffrey advised Dymphna became enraged and started screaming at him. Jeffrey stated he then went to Dymphna's purse and grabbed her medication. Jeffrey stated he believes the medication was making her crazy. Jeffrey advised Dymphna ran to her purse and grabbed her handheld Stun Gun and pointed it at him. Jeffrey stated Dymphna turned the Stun Gun on a few times and lunged forward towards him. Jeffrey advised he felt threatened and grabbed a CD case in an attempt to defend himself. Jeffrey stated he backed away but Dymphna kept coming forward. Jeffrey advised he was afraid Dymphna would stun him so he grabbed the Swiffer mop stick to create some distance. Jeffrey advised the mop did not do much to stop Dymphna from advancing, so in another attempt to defend himself, Jeffrey stated he grabbed the trash can. Jeffrey advised Dymphna continued to chase him around the kitchen with the Stun Gun. Jeffrey stated he then asked his son W/M/J Robert Galpern to bring him his phone so he could call the police. Jeffrey advised Robert was in the living room during the incident and Robert saw the incident.</p> <p>I then spoke with Robert who advised his parents were arguing and his father (Jeffrey) grabbed his mother's (Dymphna) medication out of her purse. Robert advised his mother then grabbed the Stun Gun out of her purse and turned it on a couple times and told Robert to give her back her medication. Robert advised he saw Dymphna chasing Jeffrey around the kitchen table. Robert advised his father then asked for help from Robert to bring him his phone so he could call 911.</p> <p>I then met with W/F/J Peyton Galpern, who advised she was downstairs in another room when the incident happened. Peyton advised she heard yelling upstairs and her mother screaming at her father to give her back her medication. Peyton advised she heard the loud popping noise of the Stun Gun being turned on several times and her father yelling "Don't tase me". Peyton advised she then walked upstairs where the incident was happening and saw her mother (Dymphna) holding the Stun Gun, her father holding the trash can and her brother (Robert) attempting to separate both parents.</p> <p>I then went back to speak to Dymphna and she admitted to chasing Jeffrey with the Stun Gun in her hand while turning it on several times.</p> <p>Based on my investigation and statements from parties involved, I concluded Dymphna was the primary aggressor in the incident. Dymphna was placed under arrest for simple assault pursuant F.S.S 784.011(1) for the intentional, unlawful threat by her act to do violence to Jeffrey using the Stun Gun, coupled with an apparent ability to do so, and that Jeffrey stated he had a well-founded fear that such violence was imminent causing him to flee.</p> <p>Jeffrey refused to write a statement of the incident. Robert also refused to write a statement about the incident. Jeffrey was given and signed the Dating and Domestic Violence Rights and Remedies pamphlet and the signed slip was turned in to Records. The Stun Gun was turned in to evidence.</p>
