**PROBABLE CAUSE**

Defendant was driving westbound on SR-80 and turned right onto SR-9 as I turned from eastbound behind him. Defendant accelerated to 80 mph while still on the entrance (Posted 65, Pace - FHP1700). He moved to the left lane, then back to the right lane to pass a pick-up truck. When he entered the main travel lanes defendant passed another vehicle, then drifted from lane 6 to lane 5, continuing 2' into lane 4 then back to lane 5, then slowed to approximately 60 mph. I activated my emergency lights, defendant slowed, but did not move to the shoulder. Defendant moved to the exit to SR-704 (Okeechobee BV), and finally stopped on the right shoulder of the exit.

I approached the driver's side, and could immediately smell a strong odor of an unknown alcoholic beverage emanating from the vehicle. Defendant very smugly asked what the problem was. I told him he was going 80 in a 65 and was unable to maintain a single lane. He loudly said he did nothing wrong, then let out a loud audible sigh. When he exhaled, the odor intensified. I asked him for his DL and he produced it, then slammed his wallet and phone into the center console. I asked him how much he'd had to drink and he said none, then said maybe 2 or 3 (not specified).

Defendant got out of his car at my request, after picking up his phone then slamming it down again. He loudly said he had done nothing wrong, then walked stiffly to the rear of his car, then turned and faced his car in a sort of a "parade rest" posture. I told him to relax, then placed his DL in my car. I asked him if he had any medical issues, physical defects or if he was taking any medication or drugs and he said no. Defendant agreed to perform FSTs, as follows:

HGN: swayed orbital, eyes very bloodshot and glassy, face flushed. Lack of smooth pursuit - both eyes; Onset prior to 45 degrees - both eyes, distinct at maximum, both eyes.

W&T: 3rd step paused, stepped slightly to right; 4th step, paused, stepped feet side by side, lost balance, then crossed right foot over left and paused again, took 12 steps, pivoted on balls of both feet, lost balance and stepped to rear-right, then stopped on line until I told him to walk back, only first 3 steps heel-toe, remaining 3-5".

OLS: 2 "false starts", hesitated, raised right foot, was not counting, put down after 3 or 4 seconds, continued, put down after 8 seconds.

Based upon his driving, odor, physical appearance and performance on FSTs, I determined defendant's normal faculties were impaired by alcohol. I arrested him and secured his left wrist with a handcuff and he tried to pull away with his right hand until I physically pulled it behind him. As I walked him to my car he kept tensing his muscles, and I kept telling him to relax and not resist. I secured him in my car without incident, then requested a tow.

While waiting for Steve's Towing, defendant was moody, going from loud and angry, to almost threatening, then condescending, telling me I had made a mistake. When I began to drive to the PBSO BAT, defendant began to sob and wail uncontrollably.

We arrived at the BAT, and I conducted a twenty minute observation period. During that time, he continued his mood swings, I had to remind him to sit down twice, he was reading the notices on the walls out loud, then talking to God.

Defendant was taken to a test room and agreed to take a breath test, administered by DUI Tech J. Biggs. Defendant provided 2 sample results .163/.164. Defendant refused to answer questions.



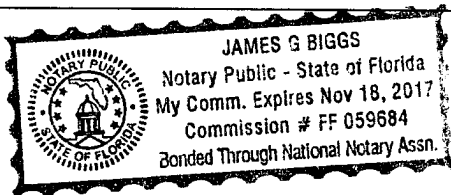
