When Jessica arrived she stated Edelmira Tesorone was standing at _____ her. _____ got in the car and _____ also tried to get in asking Jessica to take him to a hotel. Edelmira then began pushing and hitting _____ in the face. _____ was able to get in the car and they left the area. Jessica provided a sworn written statement. I then spoke with Guilherme Conto who is an exchange student that lives with Jessica and was in the vehicle during the incident. Guilherme told me he saw _____ getting pushed and hit in the face by Edelmira while he was trying to get in the car and leave with them. I then spoke with _____ who told _____ and Edelmira began arguing due to _____. _____ While gathering his belongings _____ and showed him scratches on his neck telling him Edelmira did it again. _____ stated that when Jessica arrived and they were trying to leave Edelmira and _____ began fighting again. Edelmira was pushing and hitting _____ in the face while they were outside. I then spoke with _____ who told me _____ and Edelmira began arguing about _____. _____ told me he did not see then in a physical altercation while outside because he got in the car and put his head down. I then spoke with _____ who me that _____ and Edelmira Tesorone were arguing and _____ pushed her. I asked _____ where Edelmira Tesorone was and she would not provide a specific location or time when she was returning. _____ finally told me Edelmira Tesorone would be home after picking up _____ from work. _____ would not provide a sworn written statement. 
