

I was dispatched to La Cantina, a popular Spanish club at 620 S. Dixie Hwy. In the City of Lake Worth, Florida in reference to a disturbance in progress. PBSO Dispatch received information from an unknown Spanish speaker that there was a loud argument ensuing in the parking lot and it was possibly becoming physical. Upon my arrival, a large crowd of subjects was strewn amongst both the parking lot and roadway of S. Dixie Hwy. Private security officers for the business were attempting to remove people from the club, but most were extremely intoxicated.

Amongst the group of subjects was a Hispanic female wearing a navy blue romper, later identified as Edna Paxtor. Paxtor was screaming and yelling at various subjects in the area, attempting to start multiple fights with different bystanders. Some of these bystanders felt threatened by her presence and in their attempt to avoid her, were forced out of the small parking lot and into the roadway, almost being struck by passing vehicles. Paxtor was stumbling all over the parking lot, and the odor of alcohol emanated from her person and breath. Her speech was slurred, and her eyes were glassy and bloodshot. Security officers, myself, and other responding deputies asked Paxtor to leave the property multiple times, but she was uncooperative and continued to stumble around, yelling at anyone who was near her. She then approached another male in the parking lot, getting in his face and screaming at him as if to entice a physical fight. Myself and Sgt. Yoder #7690 approached the female. She turned around and put her hands up in the air, presenting body language indicative of being ready to engage in a physical altercation. Sgt. Yoder placed his hand on the female's wrist, and she immediately pulled away. I detained her other arm, but she continued to try to pull away. Though small, the female continued to put up a struggle, until I placed her into handcuffs, making sure they were double locked and checked for proper spacing.

Based on the events that took place, I find Edna Paxtor to be in violation of the following:
 F.S.S 856.01(1) - Disorderly Intoxication, due to her being significantly intoxicated and causing a public disturbance that endangered the safety of other club-goers by enticing a physical altercation with some and causing others to be placed in harm's way when forced off into the roadway and oncoming traffic;
 and
 F.S.S 843.02 - Resist Arrest without Violence, due to her resisting and obstructing, without violence, detention by both myself and Sgt. Yoder during the lawful execution of our legal duties.
