


Smith observed a 2018 white Honda Accord bearing FL tag# JKJP44 driving at a high rate of speed going south bound in the outside through lane at approximately the 5100 block of NW 2nd Ave. According to Sgt. Smith the vehicle doubled the posted speed amount while travelling south bound. During the course of Sgt. Smith's observations the vehicle was also braking erratically for no apparent reason. The vehicle was also driving on the road way without the proper tail lamps (no tail lights were illuminated). After observing all of these patterns Sgt. Smith conducted traffic stop at the 600 block of W Yamato Road. Sgt. Smith made contact with the driver, who produced his AL DL identifying himself as white male Eduardo Desouza. While speaking with him Sgt. Smith was able to smell a strong odor of an alcoholic beverage coming from his breath. Eduardo's eyes were also red and glassy. Based on his driving pattern and the observations Sgt. Smith had of Eduardo I conducted a DUI investigation. I then met with Eduardo who was occupying the driver seat. Eduardo had blood shot red eyes and was sweating profusely while I was speaking to him. Eduardo was very chatty during the course of my observations. While speaking with Eduardo he was tongue-tied and had a strong odor of an unknown alcoholic beverage emanating from his person. I asked Eduardo did he have anything to drink and he stated he had three glasses of wine. After explaining to him that I was conducting a DUI investigation I asked Eduardo to step outside of the vehicle.</p> <p>Based on the aforementioned observations I asked Eduardo if he would submit to roadside sobriety tasks and he stated that he would submit. I then walked Eduardo over to the front of my marked patrol vehicle. While walking to the vehicle Eduardo was wobbly and was swaying back and forth. The tasks that were conducted were HGN, Walk and Turn, One leg Stand, Finger to Nose, Rhomberg balance test and the Rhomberg Alphabet.</p> <p>First, Eduardo conducted the Horizontal Gaze Nystagmus Exercise and he advised he understood my instructions. Eduardo displayed a lack of smooth pursuit in the right and</p>

left eye. Eduardo also displayed a distinct nystagmus at maximum deviation and an onset of nystagmus prior to forty five degrees in both the right and left eye. Eduardo did not follow my instructions during the course of this task. Eduardo moved his head throughout the entire task. Eduardo was also swaying back and forth and could not maintain his balance.

I then asked Eduardo to conduct the Walk and Turn task. Eduardo was unable to maintain his position during the instructional phase. Eduardo did not keep his hands down during the course of this task. While completing this task Eduardo did not walk heel to toe. Eduardo started the task twice before I told him to do so. Several times while explaining the task Eduardo started to speak and not let me talk. While conducting the task Eduardo conducted a total of 12 steps instead of the instructed amount (9 steps). Eduardo did not walk heel to toe or count out loud. Eduardo turned around instead of making a series of small steps during the exercise. Eduardo was swaying and using his arms for balance during this task.



Next, was the One Leg stand. Eduardo was unable to maintain the starting position, multiples times he started before he was told to do so. Eduardo did not follow the instructions and did not lift his feet up in front of him at first. While conducting this task Eduardo was unable to stand on one leg. Eduardo kept his arms raised during the course of the entire task. Eduardo could not complete the task and he had a hard time counting.

Next, was the Finger to Nose exercise (L-R-L-R-R-L). Eduardo did not complete the task correctly. Eduardo did not keep his head tilted back during this task. While giving Eduardo instructions he continued to interrupt me by talking. During the sequence of this task Eduardo missed the tip of his nose on all attempts. Eduardo also raised his arms in the air instead of bringing them to his side as instructed. During this task Eduardo raised the wrong arm twice when I stated right and right.

Next, was the Rhomberg Balance test. Eduardo was unable to determine when 30 second was passed. After 13 second of conducting the task Eduardo said stop (was instructed to say stop after 30 seconds). During this task Eduardo was swaying and rocking back and forth.

Lastly, was the Rhomberg Alphabet test. Eduardo was unable to complete this task. After the letter "D" Eduardo could not recite the alphabet. During this task Eduardo did not keep his arms at his side.

Based on my investigation and Eduardo's driving pattern, he was placed under arrest for DUI. While walking to the patrol vehicle Eduardo was swaying and leaning. I then transported Eduardo to the BAT facility located at the Police Department. Officer Reissi #776 acted as my breath operator. Officer Reissi and I conducted the 20 minute



