The following was captured on MVR.							
On 05/24/18, at approximately 0140 hours, I was driving northbound on Military Trail approaching Butts Rd. I observed a black 2014 Mercedes CLS550 bearing FL tag #EZYX04 sitting at the red light at Butts Rd. facing westbound. The vehicle had the headlights on and was parked approximately 4 feet past the stop bar. As I passed the vehicle, I observed a W/M, later identified as Edward Laakso, sitting slumped behind the steering wheel. I turned around and drove up behind the vehicle to check on the well-being of the driver.							
As I approached the vehicle, the engine was running. I observed a tree branch with leaves sticking out of the rear passenger bumper. I also observed fresh scratches to the paint on the roof. When I approached the driver window, I observed Laakso passed out in the driver seat with his head hung. I announced myself and knocked on the driver's window for approximately 30 seconds until Laakso finally gained consciousness. Laakso slowly unlocked and opened the door. After the driver door was open, I could smell a very strong smell of alcohol and vomit. I observed vomit on the front of Laakso's shirt and his jeans. Laakso's eyes were bloodshot and glassy.							
As I was talking to Laakso he had very slurred and slow speech. I asked Laakso if he needed any medical attention or if he was having any kind of medical issues. Laakso stated that he did not need any medical attention and that he does not suffer from any medical issues. I asked Laakso where he was coming from, and he replied that he didn't know. Laakso stated that he had been sitting in the parking lot just east of where I encountered him and that he lived right down the street. When I asked Laakso what his address was, he said, "Miramar". I asked him again what his address is and he said, "Coral Springs". I then asked Laakso if he knew what city he was in and he said, "Boca Raton". I asked Laakso if he had anything to drink and he said he had one drink. Laakso

stated that he came to Boca Raton to listen to music, but was unable recall the name of the establishment he patronized. Laakso was finally able to say that he had gone to a bar near the Town Center Mall. Laakso said he didn't know why he was parked in the parking lot and then stated that he broke up with his girlfriend tonight.

I explained my observations to Laakso and asked him if he would attempt the standard road side sobriety tasks to dispel my alarm that he was driving impaired. He said no. When asked if he had any injuries, he stated no. I explained the tasks were voluntary, but if he refused, it could be used against him in a court of law, I could use his refusal as a basis to build probable cause if I decided to make an arrest, and he was forcing me to make my decision on everything I had observed to that point. He stated he understood and had no questions. I asked him again to attempt the road side tasks and he stated no. When Laakso stepped out of the vehicle, he had a very difficult time maintaining his balance and had to lean against his vehicle to keep from falling over.

At 0203 hours, I placed Laakso under arrest. The vehicle was removed by Emerlad Towing. I transported him to BRPD.

Officer Bissoon conducted The Intoxilyzer 8000 testing. I asked Laakso to provide a breath sample. He stated, I decline. I read him Implied Consent. He had no questions. I asked him again to provide a breath sample and he stated, I decline. At 0240 hours, he was issued a refusal.

Laakso was charged with DUI FSS 316.193(1). He was given the court date of 06/26/2018 at 8:30am. The video was submitted into property. After processing, he was transported to PBCJ.
