I initiated a traffic stop on a white Hyundai Elantra tag # GBLG90. As I was making my approach I notice the driver take a drink of water. I made contact with the driver Edward Hill, introduced myself and explained to him why I was stopping him (69 in a 45). As I was talking with Edward I smelled a hint of a unknown alcoholic beverage coming from his person. I also noticed he was sweating. Deputy Valenzuela arrived and approached the vehicle while I went back to my vehicle. Deputy Valenzuela came back and informed me she can smell an unknown alcoholic beverage coming from his person as well. DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Sunday, August 6, 2017 at approximately 2358 hours, I was dispatched to Jog Road (Rd) and Boynton Beach Boulevard (Bv), Boynton Beach (Palm Beach County) Florida to assist Deputy Paul Siegel with a traffic stop that involved a possible drunk driver. Upon my arrival I noticed D/S Siegel's patrol car stopped behind a white vehicle in the #2 turn lane on Jog Rd facing north. D/S Paola Valenzuela was also on scene as a back up officer. Both deputies had their emergency lights activated. I made contact with D/S Siegel who gave the following account of this incident. While conducting speed enforcement on Jog Rd, he observed a white vehicle traveling northbound exceeding the posted speed limit. He made a U-turn and conducted a traffic stop on the vehicle for excessive speed. When he made contact with the driver he suspected him to have been drinking an unspecified amount of unknown alcoholic beverages. He asked that a DUI unit respond to his location to assess the driver for being impaired.

OBSERVATION OF DRIVER:

I made contact with the driver who was sitting in the driver seat of a white vehicle. There was also a female passenger sitting in the passenger seat. She was later determined to be the registered owner of the vehicle. She appeared to have been drinking alcoholic beverages. Focusing back on the driver, who was later identified as Edward Anthony Hill by his Florida driver license, I noticed his eyes were red, watery and glossy. His speech was slurred, mouth was dry and cheeks were flushed. He was sluggish and lethargic in his movements. I could smell a strong odor of an unknown alcoholic beverage emanating from the inside of the vehicle. He appeared intoxicated. I explained to the driver that I had a suspicion he had been drinking an unspecified amount of unknown alcoholic beverages. He told me he had not been drinking. I asked if he would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if he was impaired while operating a motor vehicle. He initially consented to performing the SFSTs, but later said if it was voluntary he would not do it. I gave the Taylor Warnings and explained the evidence that I already had against him (I.E. all previously mentioned indicators) would be strong basis for him being arrested. Afterward he told me he would comply with the SFSTs. Prior to exiting the vehicle I asked if he had any physical problems with his body that would inhibit him from performing light physical movements. I also asked if he was on medication. The defendant conveyed he neither had anything wrong with him physically, nor was he on medication. I asked him to exit the vehicle. When he exited I noticed he had trouble maintaining his balance. He swayed while walking. I escorted him to the front of D/S Siegel's patrol car and asked him to sit on the front bumper. Afterward I escorted him to a smooth and level surface that was free from obstructions and debris. The area was well lighted by the lights from my patrol car and ambient lighting in the area. I could now smell a strong odor of an unknown alcoholic beverage coming from his breath which intensified when he spoke. The following SFSTs were explained, demonstrated and acknowledged by him prior to his performance: HGN, The Walk and Turn, The One Leg Stand, The Finger to Nose and The Romberg Alphabet Recitation. His deficiencies were noted on another form on this worksheet.

DRIVER'S STATEMENTS:

Subject admitted to drinking with friends after work. He was apologetic.

ODORS:

Strong odor of an unknown alcoholic beverage coming from subject's breath.

GENERAL OBSERVATIONS

SPEECH: slurred

ATTITUDE: polite and cooperative

CLOTHING: black shirt, blue pants and black shoes

MEDICAL/OTHER: none



Other Observations:

Subject was asked to stand with their feet together and place their hands by their side. They were asked to focus on the stimulus and follow it with their eyes. Lastly they were told not to move their head to assist in following the stimulus with their eyes. Subject had equal pupil size in both eyes. Both eyes tracked equally. Both eyes lacked a smooth pursuit. I saw an onset of Nystagmus prior to 45 degrees in his left eye. Subject swayed while performing this task.

WALK & TURN:

The def was placed in the instructional stance for the Walk & Turn and given instructions. The def stated that they understood my instructions. Subject could not maintain his balance while placed in the instructional position. He swayed and ultimately abandoned the position all together. During this task subject could not maintain his balance while walking on the line. He stopped to steady himself. He took the incorrect number of steps. He turned improperly.

ONE LEG STAND:

The def was placed in the instructional stance for the One Leg Stand and given instructions. The def stated that they understood my instructions. Subject did not raise his foot the proper height as instructed. He could not maintain his balance while leg/foot was elevated. He leaned, swayed and put hi foot down.

FINGER TO NOSE:

The def was placed in the instructional stance for the Finger to Nose and given instructions. The def stated that they understood my instructions. Subject swayed while performing this task. He did not touch the tip of his finger to the tip of his nose 4 out of 6 times. Rather he touched underneath and to the side of his nose. He did not keep his eyes closed as instructed.

ROMBERG ALPHABET:

The def was placed in the instructional stance for the Romberg Alphabet and given instructions. The def stated that they understood my instructions. Subject swayed while performing this task. He did not perform this task as instructed. He sang the alphabet. He failed to recite the alphabet on three attempts.


