On the 29 day of July, 2018 at 03:32 (Specifically include facts constituting cause for arrest.)

On Sunday, July 29, 2018 at 0159 hours I responded to the 200 block of Clematis Street in reference to a disturbance. Ofc Eaton (1743), Ofc Dillard (1843) and Ofc Imbesi (1894) were working an overtime detail in the 200 block of Clematis Street. Ofc Dillard advised via his police radio that there was a disturbance.

There was an intoxicated white male that was involved in a verbal argument with Julian Sosa (manager) and Christian Desiderio (door man) of the Pawn Shop Lounge. The white male was later identified as Edward Rieck.

Edward was yelling at both Julian and Christian about entering the bar. They were refusing his entry. He was very upset and agitated. The detail officers made contact with Edward and instructed Edward to leave the area. Edward refused to walk away. He was still yelling at the officers. Eventually Edward stopped yelling and it appeared he was going to walk away.


The detail officers stepped away from Edward. I was standing on the Clematis Street watching Edward. Edward then walked back over to Julian and push and struck his chest. Then he walked over to the door were Christian was standing and again attempted to gain entry to the bar. As Christian was instructing Edward to leave I was walking over to Edward's location.

Edward then "chest bumped" Christian and it appeared that Edward was about to push and strike Christian. I grabbed a hold of Edward to control him from striking Christian. I pulled him back away from Christian. Edward then became aggressive towards me. As I was attempting to gain control of Edward he was hitting and striking my hands and arms away.

I was able to gain control of Edward's right arm. Edward was wearing loafer style

shoes. He lost his footing and caught himself from falling by using his left arm and hand. He then stood up and kept actively resist me. At this point I began to place him into handcuffs. Edward still would not comply with my commands.

Ofc Eaton, Ofc Dillard and Ofc Imbesi assisted me by controlling Edward to the ground. Edward was on his knees and I placed him into handcuffs. I stood up Edward. He was still agitated and using profanities towards me.

I could see that Edward had a cut on his hand and he was bleeding. He stated that he had cut his hand it a few days prior. He had already had medical treatment for his cut. The cut on his hand had opened up when he had lost his footing.

I then looked at my forearms and hands. I had Edward's blood on my forearms were Edward was striking me. Edward did unlawfully resist, obstruct or oppose myself, a law enforcement officer of the City of West Palm Beach, in the execution of a legal process or in the lawful execution of a legal duty, contrary to Florida Statute 843.02.. Edward was placed into Ofc Garcia's Vehicle. WPB FR 1 Responded to treat Edward's cut on this hand (Run # 18-15860).

Edward Rieck did actually and intentionally push and strike Julian Sosa against the will of Sosa and did intentionally cause bodily harm to Sosa, contrary to Florida Statute 784.03. Based on the events of the incidents probable cause exists to charge Edward with Battery and Resisting an Officer. He was transported to St Mary's Hospital for medical treatment. After he was medically cleared he was transported to the Palm Beach County Jail without incident.

Sgt Gellin and Lt Bessette responded to the scene. Christian and Julian provided sworn statements. Photographs were taken of Edward. The BWC videos and the pictures were uploaded to www.evidence.com. My BWC was activated during this police investigation. But, when Edward was actively resisting me my BWC was knocked off my chest.
