(PROBABLE CAUSE STATEMENT)								

On 6-6-14, Sgt. Whelan#1678 and I were in an unmarked patrol vehicle in the eastern portion of the of Treetops Motel parking lot (5475 Lake Worth Road, Greenacres, FL 33463). I observed a beige 1994 Buick four door bearing Florida tag 748 PPV enter the parking lot and park facing west next to room 209. A white male, known to me from past incidents as Edward L. Frederick D.O.B. 8-15-81 exited the Buick and entered room 208 at 1103hrs. At 1105hrs, Frederick exited the room and entered the driver's seat of the Buick. Based on my observations of room 208, information provided by a concerned citizen, as well as my training and experience working as a patrol officer and in an undercover capacity Frederick's actions are consistent with drug sales.

Frederick drove the Buick westbound onto Lake Worth Road failing to put on his seat belt. Because of this violation, I activated the emergency lights and sirens in our vehicle in an attempt to conduct a traffic stop as Frederick approached 57<sup>th</sup> Ave and Lake Worth Road. Frederick looked into his rear view mirror and continued to drive. At this time it was clear that Frederick did not want to stop his vehicle and was attempting to flee from us. I requested a marked unit and continued to follow Frederick at a low rate of speed. As Frederick approached the entrance to Woodlake Plaza, he turned north into the plaza and placed an unknown item in his mouth and drank from a green Mountain Dew can. It was clear at this time that Frederick was swallowing the illegal drugs he had just purchased. It should be noted that the Buick did not have tinted windows at the time of this incident. Frederick repeated this action a second time again in a clear effort to destroy the illegal drugs he purchased. I drove our vehicle next to Frederick's Buick at which time he finally stopped fleeing from us. Frederick was assisted from the Buick. When asked how much he swallowed Frederick replied, "All of it". Frederick was placed under arrest for flee to elude law enforcement and tampering with physical evidence.

While conducting the inventory prior to the Buick being towed, Sgt. Whelan and I discovered medication made out to a Herman Israel and Joyce A. Andruezewski. The medications for Israel were Cilotazol 50mg and Gabapentin 600mg. The medication for Joyce was Lisnopril 10mg, Gabapentin 100mg, Triamterene-Hctz cap 37.5mg, Lovastatin 20mg and Metformin 100mg. Sgt. Whelan was able to discover that these pills were stolen from Hamlin Place in Lantana, Florida. All of these pills were placed into evidence. Frederick was also charged with unlawful possession of prescription drugs.

Frederick was processed within the department and turned over to the Palm Beach County Jail. Frederick refused medical treatment while in custody.
