VI. DETAILS OF DUI/BUI

A. Phase 1 – Initial Observation of vessel in operation

On Saturday, November 16, 2019 at approximately 1811 hours, I, Officer Barry Partelow along with Officer J Brodbeck of the Florida Fish and Wildlife Conservation Commission, were on marked vessel patrol in Palm Beach County on the ICW. In the posted Slow Speed Zone south of Peanut Island, I observed a white in color boat bearing Florida Registration FL 0938 SL heading northbound on the ICW on a full plane. The vessel was traveling approximately 40 MPH through a posted slow speed zone.

B. Phase 2 – Personal Contact with operator of the vessel
Upon first contact with EDWARD GUERIN, I noticed that his speech was slurred, and he had an odor of an
unknown alcohol beverage emitting from his breath and his eyes were bloodshot and glassy. I saw two open beer
cans in the cup holders and a bucket that was full of empty beer cans. When asked for the vessel registration he
handed me the trailer registration.

C. Phase 3- Pre-arrest screening and Observations of Driver/Operator

HGN: During Horizontal Gaze Nystagmus, EDWARD GUERIN never followed the tip of Officer J Brodbeck's finger as instructed, numerous times. Officer Brodbeck informed me that EDWARD GUERIN displayed a lack of smooth pursuit in the both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and onset of nystagmus prior to 45 degrees in both eyes.

FTN: During Finger and Nose demonstration the subject failed to maintain the correct position. On the first exercise the subject moved his left hand missing the nose and slid his finger to the tip. At this time the subject opened his eyes and brought his head up. I explained the tasks again to the subject and started the exercise from the beginning. On each pass he was unable to bring the point of his finger to the tip of his nose.

PP: During Palm Pat, the subject did not speed up as instructed nor after being told numerous times to speed up. The subject had multiple chopped pats, began to open and close his hands like a book.

HC: During Hand Coordination, Performance Stage, the subject failed to complete the count in the first task and then skipped the second and third task. I explained all the tasks to the subject again and he said he understood. The subject started the tasks again and dragged his fists during the first task and failed to complete the second and third tasks again.

D. Arrest of Driver/Operator

At 1821 hours, I placed EDWARD GUERIN under arrest for suspicion of BUI. He was transported to the Palm Beach County Jail, Main Detention Center. I charged EDWARD GUERIN with the following violations: F.S. 327.35(1)- BUI Normal Faculties Impaired

F.S. 327.35215- Refusal to submit to lawful breath test

I issued EDWARD GUERIN a Written Warning for of the Slow Speed Zone violation.
