I responded to 13342 87TH ST N in unincorporated West Palm Beach, FL, 33412 in reference to Domestic Battery. When I arrived I met with one of the victims Ms. Mirian Alvarez, Ms Alvarez was crying. Ms Alvarez does not speak English well, so her friend Norma Quijada helped translate. Through translation, Ms Alvarez stated that she had an argument with her husband Edwin Villalta. Ms Alvarez told me she told Mr Villalta that she was leaving him. Ms Alvarez stated she went into her bedroom and went to sleep. Ms Alvarez stated that at approximately 0130 hours she was awakened by Mr Villalta sitting on top of her with both his hands around her neck. Ms Alvarez stated she became dizzy from Mr Villalta grabbing her neck. Ms Alvarez told me she yelled for help, and Mr Villalta started to pull her hair, and punch her in the face and stomach. Ms Alvarez stated that her daughter Daniella Acosta then came into the room and tried to help her. Ms Alvarez told me Mr. Villalta started to punch Ms Acosta and tried to push her out of the room.

I then spoke to Ms. Daniella Acosta. I asked her what happened tonight. Ms. Acosta stated that she heard her mother screaming and ran into her bedroom. Ms Acosta stated when she went into the bedroom she saw Mr. Villarta punching her mother. Ms Acosta stated that Mr. Villalta then punched her in her chin, shoulder and grabbed her by the hair, and tried to force her out of the room.

I then made contact with Mr Edwin Villalta. I asked Mr Villalta if he had hit or had any type of physical confrontation with Ms Alvarez, or Ms Acosta, he stated no. Based on the results of my investigation based on victim and witness statements there is probable cause that Edin Villalta is in violation of FSS 784.041(2) Domestic Battery by strangulation, and FSS 784.03(1)(A)(1) Simple Battery (Domestic).
