PROBABLE CAUSE STATEMENT

On June 9, 2018 at approximately 10:00 PM, A passerby drove up to my marked PBSO patrol vehicle in a parking lot located at 13590 S Jog Rd, Delray Beach, Florida 33446 in reference to a disabled motor vehicle. The passerby advised me he saw the vehicle stuck on a curb in a parking lot with two flat tires on the passenger side. I responded to the area to conduct a welfare check of the vehicle. I located a Red four door vehicle facing S Jog Rd. The license plate was bearing Florida tag of Y17NMC which came back to a red four door Hyundai. The vehicle was on top of a sidewalk/curb with landscaping. As I approached the vehicle in my patrol car, I could hear the vehicles engine revving and I visually observed the front passenger side wheel spinning. The front passenger side wheel did not have a tire on it and the passenger side rear tire was flat. I immediately turned on my emergency lights and siren to gain the attention of the driver as I drove up to the vehicle. I exited my patrol vehicle and observed a white female behind the wheel of the car with it still running. I approached the passenger side of the vehicle and the driver rolled down the passenger side window. I immediately told the female driver to turn off the vehicle. I could see into the vehicle and observed a part of a tire on top of the front passenger seat. The driver immediately told me she is sorry and a vehicle went in front of her. I asked the female what is going on and she stated her tire. I then walked around to the driver side of the vehicle and observed a female wearing blue jean pants and a black leather jacket. Both her steering wheel airbag and airbag at her feet were deployed. The female driver was only wearing one high heeled shoe as she exited out of the vehicle. The female driver was later identified by her Florida Drivers License as Eileen Ann Lebegue.

When speaking with Eileen, Eileen was unable to tell me how her vehicle ended up on the curb in the parking lot. Eileen stated she just wanted to get home. Eileen eyes appeared to be glassy and she had a hard time maintaining her balance as I spoke to her. DUI Investigator Schaefer #8777 was contacted and responded to the scene for a possible DUI Investigation. Case is turned over to DUI Investigator Schaefer #8777.

**Other Observations:**

Lebegue would sway roughly in a side to side front to back pattern throughout the task. She did not touch the tip of the pen as directed to positively identify the point to be tracked. Lebegue was reminded numerous times to track the pen with her eyes only. She failed to keep her head still while tracking the stimulus so was asked to hold her chin with her left hand and her left elbow with her right hand to further stabilize her head . Lebegue did not have VGN or LOC.

**WALK & TURN:**

I explained and demonstrated the instructions for the "Walk & Turn" to Lebegue who stated she understood. During the task, I observed Lebegue to sway roughly in a side to side, front to back pattern throughout the demonstration phase. She could not maintain her balance while listening to instructions. She stepped out of the instructional stance during the demonstration to catch her balance. Lebegue started the task before being instructed to do so. She would stop walking to steady herself, with pauses to regain balance. Lebegue missed heel-to-toe steps and stepped off the line. She used her arms for balance by raising them more than six inches. Lebegue performed an improper turn by turning other than which was demonstrated. Additionally, Lebegue performed the incorrect number of steps.

**ONE LEG STAND:**

I explained and demonstrated the instructions for the "One Leg Stand" to Lebegue who stated that she understood. During the task, I observed her to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Lebegue continued to sway while balancing on one leg. She used her arms to balance raising them more than 6 inches from her sides. She started hopping in an attempt to maintain balance. Lebegue failed to count out loud or by thousands as instructed. She put her foot down to regain balance numerous times before the 30 seconds had elapsed. Lebegue put her foot down three times all before counting to 30 seconds, thusly not being able to complete the task.

**FINGER TO NOSE:**

I explained and demonstrated the instructions for the "Finger to Nose" task to Lebegue who stated that she understood. During the task, I observed her to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Lebegue's index finger did not touch her nose on 5 of 6 attempts. She searched for the tip of her nose using the finger to find their nose prior to touching the tip. On L1 and L2 she touched the right nostril. On R1 she touched the left nostril. On R2 and R3 she touched under her nose. The sequence used for this task was L, R, L, R, R, L.

**ROMBERG ALPHABET:**

I explained and demonstrated the instructions for the "Rhombert Alphabet" task to Lebegue who stated that she understood. During the task, I observed her to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Lebegue would sway more than 2 inches. Lebegue correctly recited the alphabet.



## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 06/09/2018 at approximately 22:07hrs, I was called to the scene of a traffic stop at 13590 South Jog Road, which is located in unincorporated Delray Beach, Palm Beach County, Florida. I arrived at the scene at approximately 22:18hrs. D/S Adam Price #13911 relayed to me, and completed a written signed sworn supplemental Probable Cause Affidavit, that he had made contact with the defendant and her vehicle, a 2016 Hyundai Sonata bearing FL tag Y17-NMC, for a welfare check because the Hyundai was stuck on the curb in the parking lot. The defendant was revving the engine and spinning the tires in an attempt to dislodge the vehicle from the curbing. D/S Price noticed that the defendant had articulable indicators of impairment, so he called for a DUI unit to conduct a possible DUI investigation. D/S Price identified the defendant, to me, as the driver and sole occupant of the vehicle, at the time of the stop.

### OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by her Florida driver license as "EILEEN ANN LEBEGUE", I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from her person and face area. This odor intensified as I spoke to Lebegue. She had glassy, glazed, and blood shot eyes. Lebegue's speech was slurred, slow, thick, and at times difficult to understand. Her movements were slow and deliberate. Lebegue was lethargic in her movements with poor coordination. She had an unsteady gate while walking to my patrol vehicle and had difficulty following directions given to her. Lebegue was wearing a black leather jacket, creme shirt, blue jeans, and black shoes. All the clothing appeared neat.

### DRIVER'S STATEMENTS:

Pre-Miranda: Lebegue stated she did not have anything to drink but did take 1 klonopin.

Lebegue consented to breath and made post Miranda admissions that she was driving after having "1 1/2 glasses of wine".

### ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from her person and face area which intensified as I spoke to her.

## GENERAL OBSERVATIONS

SPEECH: Lebegue's speech was slurred, slow, and thick, and at times difficult to understand.

ATTITUDE: talkative, polite, friendly, cooperative, flirtatious, emotional, pleading

CLOTHING: black leather jacket, creme shirt, blue jeans, and black shoes.


