



Narrative:

In the city of Boynton Beach, within the county of Palm Beach, I, Officer D. Wagner, responded to [REDACTED] in reference to a report of an injunction violation.

Upon arrival, I met with w/m [REDACTED] (DOB 03/15/1975) who advised that his ex-wife, w/f Elisa Ostertag (DOB 08/31/1970), has been texting him and calling him which is a violation of the Domestic Violence Injunction set in place between them. [REDACTED] provided me with the Injunction for Protection Against Stalking (After Notice) which was granted on November 12, 2015 for case #502015DR010580XXXXSB against Elisa. The injunction was confirmed as active in NCIC/FCIC.

[REDACTED] stated that on 09/15/17, Elisa called him and left him a voicemail urging his nanny to call her if she "has the balls". The voicemail was downloaded as evidence. [REDACTED] also showed me several texts messages from Elisa's cell phone (# 561-777-9506) to his cell phone since that date. The messages from Elisa have been persistent and contain profanity and are demeaning in nature. The following texts from her were observed:

09/14/2017- 11 text messages
09/15/2017- 11 text messages
10/04/2017- 28 text messages
10/05/2017- 16 text messages
10/08/2017- 13 text messages
10/21/2017- 27 text messages

Elisa has a history of domestic violence and violating the injunction. Her current address has not been confirmed as [REDACTED] stated she has been moving around for rehab.

Based on the aforementioned, I found probable cause to charge Elisa with Violation of a Domestic Violence Injunction in violation of F.S.S. 741.31(4)(a)5. Charges will be filed with the State Attorney's Office. [REDACTED] received a Victim's Rights Brochure with a case number and he signed an Exemption from Public Records form. His statement was captured via my body worn camera.
