<p><b>I was dispatched to 1974 E CHATHAM RD in unincorporated West Palm Beach in Palm Beach county reference to a domestic dispute.</b></p> <p>Prior to my arrival I was advised via dispatch that the complainant Christina I Blythe was experiencing a domestic dispute with her boyfriend Eliud M Vences. I was also advised via dispatch Christina "she gave her gun to the boyfriends mother". Christina informed dispatch she believes Eliud will be aggressive with law enforcement when deputies arrive and she is currently hiding in the bathroom.</p> <p>Upon my arrival I made contact with Eliud and Eliud's father Armando M Vences outside the residence. After identifying myself as a deputy with the Palm Beach County Sheriff's Office both Eliud and Armando became uncooperative and aggressive. Eliud told me to "fuck off" and "get off my property" and refused to answer my questions. I attempted to explain to Armando that we received a phone call from a female stating a domestic dispute was in progress and there was a mention of a gun. Armando told me to leave his property and told me no one called at the residence. Armando stated "I looked nervous and should probably leave". Both Eliud continued to refuse to listen to my explanation as to the lawful reason why I was present at the residence. I radioed to dispatch to call the complainant Christina to step outside the residence so I could ensure her safety and to prevent the current hostile situation with Eliud and Armando from escalating, however I was advised dispatch was met with negative results when attempting to call Christina.</p> <p>At this time, due to the exigent circumstances that the complainant was not answering dispatch's phone call and how Eliud and Armando were not cooperating with my investigation I needed to make entry inside the residence to ensure the safety of the complainant Christina. I told Eliud and Armando I was going to enter the residence at which time both told me no I was not. As I reached for the doorknob Armando grabbed my hand. As I was opening the door, I felt Armando push the door close to prevent me from entering the residence. I continued to pull the door open as Armando attempted to close, I managed to push my torso partway through the doorway. I felt the doorway continue to close on my torso, so I continued to push the door open in order to enter the residence. So in order to prevent injury to myself, I pushed the door open which caused Armando to be placed in-between the door and wall of the residence.</p> <p>As Armando attempted to grab the doorknob Eliud followed behind him. Cpl. M Wells (ID 8025) prevented Eliud from approaching the doorway due to his previous aggressive posture and statements by placing his arm out and pushing him back. Eliud continued to yell and ignore Cpl. M Well's instructions to back away. Only until both Eliud and Armando were placed in handcuffs and removed from the scene were deputies allowed to speak to the initial complainant Christina and confirmed no crime took place between her and Eliud.</p> <p>Due to the facts committed in my presence I found Armando did intentionally touch and push the door against myself, a while engaged in lawful duty as deputy with the Palm Beach County Sheriff's office and obstructed my investigation by attempting me to enter the residence to investigate a domestic dispute complaint per F.S.S. 784.07(2b) and F.S.S. 843.02. Also due to the facts committed in my presence I found Eliud attempted to prevent me from entering the residence to investigate a domestic dispute complaint per F.S.S. 843.02.</p>
