committed the below acts in my presence. was observed by _____ who told _____ that he/she saw the arrested person commit the below acts.

confessed to _____ admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.

On the 14 day of APRIL 2018 at 1642 A. M. P.M. (Specifically include facts constituting cause for arrest.)

I responded to 56 Canterbury C located in unincorporated West Palm Beach Florida in reference to a battery.

Upon arrival I observed a white male, later identified by name as Scott Emerson, who appeared o be bleeding on his right hand and from his left ear. Emerson advised his girlfriend advised his girlfriend of 3 years, Elizabeth Stone, "slapped" him in the ear and scratched him on the hand. He stated he came home from work around 1500 hours this afternoon and when he arrived at the residence Stone was already drunk from drinking Vodka. She asked him for money and when he would not give her any she "started attacking" him. The physical happened in the residence. I asked if she had any weapons that she used and he advised she did not, she only used her hands. It should be noted I located several drops of blood outside the residence, 56 Canterbury C. I asked if anyone witnessed the incident and he stated his roommate "Joe" was home at the time. I asked Emerson if he has thin skin or takes blood thinners and h stated that his skin is thin and he bruises easily. I observed two small deep scratches on the top of his right hand and dried blood in his left ear. I asked how he got the blood in his ear and he stated he did not know he just remembered him "bitch slapping" him.

I made contact with "Joe" who stated that he did not want to be involved and would not provide me with a statement.

At this time, biased on statements given and consistent injuries, I find probable cause to arrest Elizabeth Stone for the charges of Battery (simple) Domestic Fss784.03(1)(a)(1).

Contact with Stone was made at the residence where she was placed into department approved handcuff, checked for fit and doubled locked. She was then placed into the back seat of my marked patrol vehicle and transported to the main detention center, seat belted, without incident.
