

Jupiter Police communications further advised that a white female bar patron was also causing a disturbance at the upstairs outside bar. The female was described as having long blonde hair wearing a tank top type shirt. Upon arrival, I made contact with several subjects located in the parking lot who advised they were involved in the altercation. These subjects stated the altercation started with a blonde female subject and her boyfriend while at the bar. While speaking to these individuals, I could hear a female voice shouting obscenities from the upstairs outside bar. Another male subject approached me and stated he was playing live music at the bar. He stated an intoxicated blonde female had thrown his guitar and papers around the upstairs bar area where he was playing.</p> <p>Ofc Flesch and I responded to the upstairs bar area and made contact with a blonde female later identified as Elizabeth Harding 07/17/71 and a male subject she identified as her boyfriend. Harding was cursing and shouting obscenities, such as "Fuck this bar, fuck you people" "This place is fucking ridiculous". I asked Harding to lower her voice several times, and Harding continued shouting and stated "I don`t have to do fucking shit". There were several bar patrons in this particular area, and Harding`s actions were causing them to stop and stare as she continued to shout. Ofc Flesch and I continued to speak to Harding and attempted to calm her down while requesting that she lower her voice. Harding continued with her actions.</p> <p>I responded to the 1st floor of the restaurant and made contact with the restaurant owner Scott Thompson 03/03/57. Thompson stated that he witnessed Harding`s disorderly behavior and requested that Harding be issued an indefinite trespass warning for his business.</p> <p>Ofc Flesch advised me that Harding was now downstairs in the main restaurant area</p>

where I responded to advise Harding about the owner's trespass request. Harding continued shouting obscenities and stated "fuck you guys, fuck you" several times. I advised Harding that she was no longer welcome in the business and Harding continued shouting and cursing at officers. Harding refused to comply with previous requests to calm herself down and cease her disorderly actions. Harding's boyfriend also made several attempts to calm her down unsuccessfully. I then placed handcuffs on Harding and advised her she was under arrest for disorderly intoxication. Harding was escorted to the outside of the business towards my patrol car which was parking on the south side of the parking lot. Harding continued shouting and then refused to walk with officers. Harding's legs went limp and she allowed herself to go down onto the pavement. Harding began to twist her body as I attempted to escort her to a seated position. Harding then began to kick both legs repeatedly, striking me in the chest and left arm. Harding was verbally advised several times to stop resisting and kicking her legs. Harding continued to twist her body and kicking her legs, causing her shoes to fall off. A hobble restraint was utilized to secure Harding's legs preventing her from further kicking and possibly injuring officers. Harding then began spitting at officers several times.

Harding was then escorted over to my patrol vehicle by Ofcs Flesch, Marrinucci and I. We had difficulty placing Harding in the rear of my patrol car as Harding refused to comply with our verbal commands. Harding was eventually secured (seat belted) in my patrol car and transported to Jupiter Medical Center due to her high level of intoxication. Harding had slurred speech, bloodshot/watery eyes and the known odor of an alcoholic beverage emanating from her person.

Upon arrival at Jupiter Medical Center, the rear door of my patrol car was opened and Harding began spitting towards officers. A safety mask had to be utilized and placed over Harding's head to prevent her from further spitting at officers. Harding was escorted into the emergency room via wheelchair, and Harding continued shouting racial slurs and obscenities once inside disrupting the hospital guests and staff. Harding was treated, and subsequently transported to the Palm Beach County Jail once her level of intoxication was at an acceptable level.

Based upon the above facts, being that Harding caused a significant disturbance inside a business establishment, being disorderly while intoxicated, I believe probable cause exists to charge Harding contrary to FSS 856.011. Additionally, during the lawful arrest of Harding and subsequent intentional kicking and striking of a police officer while in full duty uniform in the performance of such duty, I believe probable cause exists to charge Harding with battery on a law enforcement officer contrary to FSS 784.07 (2)(b) and resisting arrest w/violence contrary to FSS 843.01.
