The following incident occurred in the City of Delray Beach, Palm Beach County, Florida. On 05/16/19 I observed a white BMW bearing AZ tag CHG8688 do an illegal U-Turn on W Atlantic Ave just east of the CX transportation train tracks. In my fully marked police vehicle, I activated my emergency lights and sirens and stopped the BMW at W Atlantic Ave and I95. I made contact with the driver, Christian Rosado who was identified by his FL DL. Rosado appeared very nervous, was sweating profusely, and was visibly shaking. I asked Rosado if there was anything illegal in the vehicle and he said no. I asked him if he would give me consent to search the vehicle in which he also stated no. Rosado and the passenger, Elizabeth Pompa appeared very nervous, so I requested K9 Ofc Mintus to conduct a narcotics sniff. When Ofc Mintus arrived, we told Rosado and Pompa to step out of the vehicle. Ofc Mintus asked Rosado again if there was anything illegal in the vehicle and he stated he was not sure. Ofc Mintus got K9 Ghost out and informed me that K9 Ghost alerted to the vehicle. I began searching the vehicle on the passenger side and located a red purse that contained Pompa's passport. Inside of the purse, there was an Ibuprofen bottle that contained a white pill labeled TEVA 5553. I researched the pill on Drugs.com and the website stated the pill is a scheduled II substance that is available by prescription only. In another pocket in the purse there were two small zip top baggies containing a white powder substance. Based on my training knowledge and experience, I suspected the white powder to be cocaine. The substance was field tested utilizing a cocaine test kit in which it yielded positive as such. Also located on the passenger seat was a plastic shopping bag that contained a sealed glass bottle. In the glass bottle was a green leafy substance. Based on my training knowledge and experience, I suspected the substance to be marijuana. The substance was field tested utilizing a Marijuana test kit and it

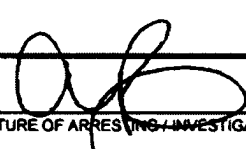
