

 On the 30 day of October, 2017 at 00:26 (Specifically include facts constituting cause for arrest.)

On 10/29/2017 at 2249 hours, I responded to the Publix located at 4200 Northlake Blvd, Palm Beach Gardens, Palm Beach County Florida in reference to a suspicious vehicle. The manager of Publix contacted this agency to advise that he observed a white van located on the east side of the parking lot (after closing hours) making leaving employee's uncomfortable and/or concerned.

Upon my arrival, I observed the white van bearing Florida tag 561pda backed into a parking space located on the far east side of the listed parking lot on private property. The listed van was stationary with all illuminating lights off. The listed vehicle was occupied by suspect/defendant Emelie Madeline Fayle Chong (located in the rear seat), Ethan Kennedy (located in the front passenger seat) and Aaron Meisner (also located in the rear seat). Upon making contact with the subjects, all parties advised they were at that location to sleep. I requested all subjects to exit the vehicle while I conducted my investigation for officer safety purposes. It should be noted, the rear windows of the listed van were "blacked out" and I was unable to view the rear seat passengers. As the three subjects were exiting the vehicle, I observed the defendant Chong remove a syringe containing a clear liquid substance (suspected Heroin) from her right sweater pocket and drop it (syringe) on the floor. I immediately collected the listed syringe.

In a post Miranda interview Chong advised she did not know the syringe was located in the sweater. Chong advised the sweater did not belong to her. Chong advised the sweater belonged to Aaron Meisner, however Chong stated she has been wearing the sweater for an extended period of time. Chong advised she did not know what substance was located in the syringe, but assumed the substance to be Heroin. Chong advised she had a drug problem in the past. I did observe "track marks" located on Chong's arms. It should be noted the syringe contained a substance, so in fact the plunger was extended making the syringe longer in size indicatining the syringe was loaded.

In a post Miranda interview, subjects Kennedy and Meisner advised they do not use Narcotics and have not observed Chong using Narcotics in their presence. Kennedy and Meisner advised Chong does walk away from the van for extended periods of time. Kennedy and Meisner both confirmed that Chong has been wearing the sweater for multiple hours.



The listed substance was field tested using a Naro test kit for Heroin and/or an Opiate derivative. The field test revealed a positive notification. The listed Heroin provided an approximate total package weight of 3.2 grams.

Through my investigation, I found probable cause to exist for Emilie Chong, in reference to F.S.S 893.13 (6A) Possession of a controlled substance w/o a prescription and F.S.S 893.147 Possession of drug paraphernalia. Chong was placed under arrest and transported to the Palm Beach County Jail without incident.

The syringe containing the Heroin was placed into evidence. My department issued body worn camera was utilized. I completed a tracking citation in reference to citation number A7GESYE.

The other occupants of the van were non licenced, released from the scene, and refused to take custody of the van. The van was properly parked and left at the scene since it had no evidentiary value to this case.
