

Upon arrival I met with Asset Protection Representative, Luca Rispoli who had two females, later identified as Koreen Varney and Emily Hise detained after they took merchandise from the store.</p> <p>According to Rispoli, at approximately 1423 hours while he was on the sales floor he observed two unknown females (later identified via Michigan Drivers license as Koreen Varney and Emily Hise via Illinois Drivers license) showing suspicious activity. Hise and Varney were seen carrying large Pacsun store bags that seemed relatively empty. Hise and Varney were in the women's active wear department selecting multiple items from nearby fixtures. Rispoli also notified AP Representative, Dwight Kenon who was in the AP office. Hise and Varney entered a clean active wear fitting room together but upon their exit AP Valerie Chacon was able to determine several items were still missing. Hise and Varney then began selecting items from a nearby Calvin Klein fixture and then selected items from the women's swimwear department. Both females entered another fitting room together in the swimwear department. AP Representative Eleycia Lopez assisted with this fitting room surveillance. Hise and Varney exited the fitting room and after inspection it was determined multiple items were missing from the fitting room. Rispoli advised the bags being carried by Hise and Varney were now noticeably larger. Hise and Varney made their way through several women's and men's departments, went down to the first floor via the escalator and then exited the store via the East exit/entrance. Hise and Varney passed all points of sale never making any attempt to purchase the concealed merchandise. AP Valerie Chacon made contact with Hise and Varney as they exited the store and they were escorted back to the AP office. Rispoli recovered all of the stolen merchandise from the bags Hise and Varney were carrying. The total amount of recovered merchandise from Emily Hise was \$963.08. The total amount of recovered merchandise from Koreen Varney was \$447.56. The total for value for both was \$1,410.64.</p>

	<p>I then met with Hise and Varney who were sitting in the AP office. I read Hise and Varney their Constitution Rights from my pre-printed Miranda Warnings department issued card. Hise and Varney advised they understood their rights and agreed to answer my questions. Hise and Varney individually stated that they intentionally stole the items while working together. Hise and Varney appeared extremely remorseful.</p> <p>Based on my investigation, Emily Hise and Koreen Varney were placed under arrest and charged with violation of F.S.S 812.014(2C1) Grand Theft. Emily Hise and Koreen Varney intentionally obtain property that was not theirs; therefore, depriving Macy's of their merchandise, value of merchandise was more than \$300 but less than \$5,000.</p> <p>Hise and Varney were both issued Trespass Warnings for Macy's. I transported Hise and Varney to BRPD for processing and then transported to Palm Beach County Jail.</p> <p>Luca Rispoli provided a written Witness Statement, two sales receipts of the stolen merchandise and two pictures of the stolen merchandise, all of these items were placed into to BRPD evidence.</p>
