Ofc. Bango and Ofc. A. Mazza also arrived on scene. Upon arrival, I met with Breakers Security Officer Romilus Gustave. Gustave informed me that the female sitting on a chair outside the "seafood bar" (later identified via Tennessee driver's license as Emily Reardon DOB 05/04/94) was being disorderly and causing a disturbance to the other patrons of the restaurant.</p> <p>Breakers Security informed me that Reardon had attended a private function with two other individuals, one W/M Warren Thomas DOB 09/07/93 (770-842-5064) identified by his Georgia driver's license, and an unidentified female who was not present.</p> <p>Upon contact with Reardon, she appeared to be heavily intoxicated, distraught, with eye make-up smeared, bloodshot eyes, and her speech was slurred. I made several attempts to determine the cause of her behavior, at which time Reardon became argumentative. She went on to use profanity, calling myself and the other officers on scene "assholes" and other names in presence of children and other patrons.</p> <p>It was at this time Reardon was placed in handcuffs as a precaution of her becoming physically confrontational. In order to not disturb or worry other guests at the Breaker's Hotel, Ofc Bango and Gustave escorted Reardon to the ballroom.</p> <p>Due to Reardon's intoxicated condition, inability to care for herself, danger to others and disturbing other guests at the hotel in the presence of police officers, Reardon was placed under arrest for disorderly intoxication pursuant to F.S.S. 856.011.</p> <p>Ofc. Bango and I escorted Reardon to my patrol vehicle (#805). Reardon continuously asked why she was being placed under arrest, and was told repeatedly for disorderly intoxication. While walking to my patrol vehicle she became irate, screaming, refusing</p>

to walk, and yelled, "help me" and "rape" several times. Reardon continued this behavior, telling Ofc Bango and myself that she would "kill us" and we are "pieces of shit". At this point, Reardon refused to walk, her body becoming limp, forcing myself and Ofc Bango to carry her to the patrol car.

While in transit to the Palm Beach Police Department, Reardon kicked the divider to the rear seat of the patrol car and unbuckled her seatbelt.

While in the holding cells at the Palm Beach Police Department, Reardon continued to yell profanities while I was preparing paperwork for booking at the Palm Beach County jail.
