On Wednesday, July 18, 2018 at approximately 0834 hours, I responded to 5959 ORANGE RD, unincorporated Palm Beach County FL, in reference to a domestic battery in progress. While en-route to the call, it was informed the complainant later identified as Emily Kochis was standing across the street from her home and the male half later identified as Jose Centeno left the area in a red vehicle away from the incident location.

Upon arrival to the aforementioned address, I made contact with the complainant who informed me that approximately two weeks ago her ex-boyfriend Jose pulled a gun to her head. She advised after he texted his godmother about it, he got upset, took her phone and smashed it on the floor. According to Emily, after Jose smashed the phone on the floor, she scratched his back out of anger. She further advised Jose was on probation and had a gun on him.

Responding units made contact with Jose just down the street and brought Jose back to the house. Upon making Jose, he informed me that around 0800 hours this morning while he was in the shower he received a text from his godmother stating that he pulled a gun on Emily. According to Jose, when he exited the bathroom and confronted Emily on why she was telling lies to his god-mother she told him "leave or I will call the cops". Jose said since he was on probation, she decided to leave the residence in order to avoid a physical altercation but as he walked away from Emily, she scratched his back.

While talking to Jose, I observed multiple scratches on his back. The physical evidence, were consistent to the statements they both provided. I asked Jose if he needed medical attention but he said "no". At this time, I obtained a sworn statement from Jose. I provided him with a Victim/Witness rights and case information form. He also received a notice of legal rights and remedies. I submitted a 911 tape request for the state attorney. I took digital photographs of Jose's injuries and entered them into the PBSO Domestic Violence System.

Based on my findings, the complainant's statements, the injuries I observed and the evidence that were presented to me, I find that probable cause to charge EMILY KOCHIS for the crime of simple battery (domestic), pursuant to Florida Statute 784.03 (1)(A)(1). At this time, Emily was arrested and placed in handcuffs. Handcuffs were checked for tightness and double locked. She was then transported to the county jail without incident. This case is cleared by arrest.
