On the 23 day of May, 2019 at 02:39 (Specifically include facts constituting cause for arrest.) On 5/23/19 I was on crime suppression patrol traveling south on NW 8th Ave in approximately the 400 block when a white passenger vehicle, traveling north in the same area, turned on their high beams, causing me not to be able to see. The vehicle then continued traveling north, going through the stop sign in the 500 block of NW 8th Ave, and continuing north. I turned around and was able to conduct a traffic stop on the vehicle, a white Nissan Altima bearing FL tag # KBH P29, in the 700 block of NW 8th Ave. Upon making contact with the b/f driver, who I identified as Rachelle Buchanan through her FL DL, and her w/m front seat passenger, who I identified through his FL DL as Emre Atici, I could immediately smell the strong odor of marijuana emanating from the vehicle. I explained the reason for the traffic stop to Buchanan and then informed her and Atici that I could smell the odor of marijuana coming from inside the vehicle and asked if they had any. Both parties continuously denied having any marijuana inside the vehicle currently or previously. Ofc. Tyson then arrived on scene shortly after as a backup officer. I asked Ofc. Tyson to have Atici step out of the vehicle. Upon Atici opening the front passenger side door and stepping out, Ofc. Tyson observed a clear plastic baggy containing a green leafy substance that he recognized through his training and experience to be marijuana in the lower pocket of the door. He then informed me, and I also observed the baggy containing the green leafy substance which I also recognized through my training and experience to be marijuana. There was also an unlabeled orange pill bottle containing several pills on top of the plastic baggy. I then retrieved the items and opened the pill bottle. Inside I observed several small oval shaped orange pills scored "20" on one side and "b 973" on the other. I then contacted poison control and spoke with Operator Pablo, ID M3591467, who identified the pills as Adderall (20mg).

	Prior to speaking with Atici about the green leafy substance and the pills, I read him his Constitutional Warning (Miranda Rights) and he agreed to speak with me. Post Miranda, Atici told me the green leafy substance in the clear plastic baggy was marijuana and it belonged to him. He initially denied knowledge of the pills (Adderall) in the unlabeled pill bottle, but later admitted they belonged to him and that he does not have a prescription for them. Atici claimed both are for personal use only. The green leafy substance was field tested positive as marijuana using a QuickCheck test kit by Ofc. Tyson. It was weighed and produced a weight of 3.2gms. Ofc. Tyson counted 29 Adderall pills and they produced a weight of 7.1gms. He then placed the marijuana and Adderall into BRPD evidence. Based on the facts of the incident, Atici was placed under arrest for possession of a schedule 2 substance without a prescription in violation of FSS 893.13(6a) and possession of less than 20gm of marijuana in violation of FSS 893.13(6b). He was transported to BRPD booking for post arrest processing and later TOT CJ.
