Narrative:

On February 20, 2017 at 0936 hours I responded to 1351 S Federal Highway in reference to a domestic battery. Upon arrival I made contact with the reporting person B/M Michael Nelson (DOB 09/27/62). Nelson advised he was flagged down by W/M Enea Asllanaj (DOB 07/09/97). Asllanaj advised Nelson that he and his girlfriend W/F Lauren Stewart (DOB 05/22/97) were in a physical altercation and to contact police. Nelson did not witness the physical altercation.

I made contact with Asllanaj who advised he and Stewart were arguing in reference to a cell phone. He advised out of anger he punched some mirrors at their residence (1581 S Federal Highway Boynton Beach FL, 33435). The argument continued and escalated to a physical altercation. Asllanaj took Stewart's cell phone from her at which point Stewart "tapped" him in his genitals twice and scratched his face. Asllanaj advised he grabbed her arm and shoulder to stop her, but did not hit her. Asllanaj stated "I provoked her, I don't want her to get in trouble for this." I observed an injury to Asllanaj knuckles on his right hand and redness under his left eye.

Officers responded to 1581 S Federal Highway to make contact with Stewart, however no contact was made. As officers were exiting the community; Ofc. E Lampe was flagged down by Stewart in front of 1415 S Federal Highway. Upon arrival I made contact with Stewart who was visibly distraught. Stewart advised she was in a verbal altercation with Asllanaj inside their residence. Asllanaj became angry and punched 2 mirrors in the residence. Asllanaj then snatched Stewart's cell phone from her. Stewart advised she reached for her cell phone and a physical altercation began. Stewart tried to retrieve her cell phone and Asllanaj scratched her arm in the process. Stewart denied hitting him. I observed a 1/4 inch scratch on Stewart's left arm. Stewart refused medical attention.

Based upon the above facts, physical injuries, and Asllanaj's confession it was determined Asllanaj was the primary aggressor. Asllanaj was placed under arrest for Simple Battery (Domestic) pursuant to FSS 784.03 (1).
