PROBABLE CAUSE

On the above date and time I was in service in Palm Beach County, FL. The weather was clear and traffic was moderate. At approximately 10:39 PM a BOLO (Be On The Look Out) was dispatched for a silver in color Jeep with a black top traveling southbound on Interstate 95 (State Road 9) south of Palm Beach Lakes Blvd that was described to be driving all over the roadway and unable to maintain a single lane. The caller also advised that the silver in color Jeep was driving off the roadway onto the left paved emergency shoulder almost colliding with the concrete median barrier. As the BOLO got closer to my location I then advised dispatch that I would attempt to intercept the silver in color Jeep. Dispatch then advised that the silver in color Jeep was now approaching Gateway Blvd. I then advised dispatch that I was on the southbound entrance ramp from Gateway Blvd and had a visual on the silver in color Jeep in the HOV lane. I observed the silver in color Jeep bearing the Florida tag of, 220JFJ, unable to maintain a single lane as it drifted off into the inside center lane and back into the HOV lane. I then activated my emergency lights and sirens in an attempt to conduct a traffic stop on the silver in color Jeep. The driver of the silver in color Jeep then pulled off to the left paved emergency shoulder just north of Boynton Beach Blvd (State Road 804). I then approached the silver in color Jeep on its driver side and observed a white male in the driver seat. The white male driver was later identified through his Florida Drivers License as, Eric Albert Holzschuh 09/13/1985. Upon coming into initial contact with Mr. Holzschuh I observed his eyes to be glossy and red in color. I then advised Mr. Holzschuh the reasoning of the traffic stop and if there was any reason as to why his driving pattern was the way it was. Mr. Holzschuh then advised me that there was no reason for it. I then could smell the odor commonly associated with the smell of an unknown alcoholic beverage emitting from Mr. Holzschuh's breath as he spoke to me. I then asked Mr. Holzschuh where he was coming from. Mr. Holzschuh then advised me he was driving from St. Lucie. Mr. Holzschuh's speech was slurred and mumbled. Mr. Holzschuh was then asked to turn off his vehicle and to then provide me with the necessary documentation to identify himself and the vehicle. As Mr. Holzschuh was looking for the documentation I requested of him I then observed an open Budlight beer bottle in the center console of the vehicle. After Mr. Holzschuh provided me with the documentation I requested I then asked if he had anything to drink prior to driving his vehicle. Mr. Holzschuh then advised me that he did not have anything. Mr. Holzschuh was then asked to step out of his vehicle and followed me to the front of my patrol vehicle. When coming into contact with Mr. Holzschuh outside of the vehicle I then advised him the reason I requested for him to step out was because I had reason to believe he was driving under the influence of alcohol. I then asked Mr. Holzschuh once more if he had anything to drink prior to driving his vehicle. Mr. Holzschuh then advised me again that he did not. I then explained to Mr. Holzschuh my observations and what I was smelling as he spoke to me and again if there was a reason for his driving pattern. Mr. Holzschuh advised me that he works late nights. Mr. Holzschuh was then asked if he was coming from work now. Mr. Holzschuh then advised me that he was not and that he was out with coworker's. Mr. Holzschuh was then advised that I would now be requesting for him to perform a series of roadside exercises. Mr. Holzschuh then questioned my request. I then advised Mr. Holzschuh that the reason of my request was because I had reason to believe he was driving under the influence of alcohol. Mr. Holzschuh was then requested again to perform the series of roadside exercises. Mr. Holzschuh then advised me that he did not feel the need to perform them and advised that he would not perform them. I then advised Mr. Holzschuh that if he refused to consent to perform the series of roadside exercises that I would be placing him under arrest for driving under the influence based off my observations. Mr. Holzschuh was then again asked to perform the series of roadside exercises and again refused to do so. (See Video)

After the defendants 20 min observation he was then given the opportunity to provide a breath sample in which he refused at 11:46 PM.
