. In the process of grabbing/ pulling on her shirt which he ripped off of her while trying to pull her up. [REDACTED] said he could not get her up and she remained on the ground trying to protect herself and that's when he began to pull on her by her arms and legs leaving scratches to her arms, and the neck area. [REDACTED] said Eric then slapped her in the face with an open hand. [REDACTED] stated that he used his right hand to hit her to the left side of her face, leaving a red mark with swelling to the left side of her face. She stated that after Eric slapped her in the face he dragged her from one of her arms and one of her legs. [REDACTED] told me Eric dragged her from Eric's bedroom down the hallway all the way to the front door, and after he got to the front door he was not able to open it due to [REDACTED] having her other foot pinned against the door so he would not open it. [REDACTED] said Eric than let her go, went to his bedroom and that's when he called [REDACTED] [REDACTED] said she waited in the living room area with her [REDACTED] waiting for [REDACTED] which arrived at 1615 hours and thats when [REDACTED] and [REDACTED] ran out to [REDACTED] conducted an In-Car video sworn recorded statement, which will be submitted into evidence.

I then Spoke to [REDACTED] who stated that he and [REDACTED] Eric arrived home from work on 12/30/2017 in the afternoon. [REDACTED] said [REDACTED] was having a bad day as on his way home he got a flat tire on I95. When they arrived home [REDACTED] said that [REDACTED] started to argue about her cleaning the house. Upon asking [REDACTED] where in the house was he during the argument, he stated that he was in the living room and didn't see anything. [REDACTED] stated he did hear the arguing but did not see anything that occurred in the bedroom. [REDACTED] said he did see [REDACTED] being dragged from the hallway down to the front door, at which point he said Eric let go of her leg and arm and Eric then went to his room. [REDACTED] said he and [REDACTED] waited for [REDACTED] to arrive. [REDACTED] said that once [REDACTED] arrived both he and [REDACTED] went out to the car and left. [REDACTED] provided me with a sworn in-car video statement, which will be submitted into evidence.

I then relocated to the incident location 9875 Pineapple Tree Dr, Boynton Beach, FL 33463 to speak to Suspect Eric Faraguna. Post Miranda, Eric was short worded when talking to me and stated that he arrived home to notice that his [REDACTED] had not done the only thing he asked her to do (Clean the House). He said they only had a really bad verbal argument about not cleaning the house. Eric told me that he told [REDACTED] that she had to leave his house and go to [REDACTED] house. He said she then went into his room and he tried to get her out by grabbing her arm with reasonable force and tried to escort her out of his room.
