


On May 9th 2019 at approximately 1945 hours, Scarlett was at the Sunoco Speedway located at 9250 W Indiantown Road Jupiter FL 33478, where she got out of her vehicle to let her dog out. Scarlett was placing the leash on the dog when Scarlett's ex-boyfriend (Eric Giambagno W/M DOB 11/28/1991) snatched the leash out of her hand.

Scarlett stated Giambagno and her have dated in the past which got physical. Scarlett further stated that she has a protection order on Giambagno. Scarlett also stated that her hearing for the protection order is on May 16th.

Scarlett further explained that Giambagno stated that she would get her dog back if she dropped the charges. Scarlett stated when Giambagno snatched the leash from her, she became fearful. Scarlett stated her friend (Hughie Baker W/M DOB Unknown), who allegedly works at Jupiter Farms Pizza, was outside when this event occurred. Baker then told Giambagno to give Scarlett her dog back. At that time, Scarlett snatched the leash from Giambagno.

Scarlett explained that once she retrieved her dog she went back inside her vehicle to leave. Giambagno parked his vehicle behind Scarlett's vehicle so that she could not move. Scarlett then stated that she called her brother (Nick Scarlett). She then told Giambagno that Nick was coming. Giambagno then proceeded to leave the premises.

Scarlett gave a sworn recorded victims statement on my BWC. Scarlett was given a Domestic Violence Brochure. Scarlett was also advised that if she had any other information regarding this incident, to contact the Jupiter Police Department. The whole incident was captured by BWC.

I attempted to make contact with Giambagno via a phone call with negative results. I left a voicemail stating that I needed to talk to him about the above incident. Giambagno called me back approximately fifteen (15) minutes after leaving him the voicemail. Giambagno stated that he could not come in but would come in the next day (5/10/19) but never came in.

I also attempted to call Scarlett back for further questioning; I left two voicemails with negative results. I also contacted Sunoco. I made contact with Miki (the store manager) who stated that there are no cameras outside of the establishment. The only cameras on the premises are inside the establishment.



Included in this report is existing Domestic Violence Injunction Order issued by Palm Beach County.


