In the course of the fair parade a white male later identified as Eric Schaefer stepped into the route of the fair pushing another male in a wheel chair. When requested to move out of the route of the parade by security officer Robert Davis, Eric refused to move and began yelling obscenities loudly at myself and officer Davis. ("Fuck you, I'm not moving" "I don't have to do shit" "Go fuck yourself" "I'll kick your fucking ass.") Security Officer Davis informed myself and Sergeant Obrey that Eric was to be issued a trespass warning and ejected from the fairgrounds. At which time Sergeant Obrey and I made contact with Eric and requested him to exit the fairgrounds via gate #2. | <p>While at Gate 2 Eric was issued a trespass warning by Security Officer Davis. While seated and waiting for a taxi to come and pick Eric up, Eric began striking Officer Davis in his left leg with a closed fist. As deputies approached Eric to take him into custody for the battery on Security Officer Davis, Eric lunged at Sgt. Miller #7704 and interlocked his arms around Sgt. Miller's left leg causing Sgt. Miller to fall. Sgt. Obrey, Sgt. Miller, Sgt. Daly and myself were all required to physically restrain Eric and to place Eric into handcuffs. While attempting to restrain Eric, he attempted to bite Sgt. Miller's leg , attempted to spit saliva on deputies, and kick deputies repeatedly.
