On the above date and time [REDACTED] was operating in an undercover capacity to combat street level prostitution in the City of Lake Worth. [REDACTED] was in plain clothes and driving an unmarked vehicle while being monitored by [REDACTED]

[REDACTED] saw a female identified as Erica Harwell (Defendant) walking North in the 400 block of North "H" Street, within the City of Lake Worth, Palm Beach County FL. [REDACTED] stopped his vehicle where the defendant approached the passenger side door and entered the vehicle. [REDACTED] then asked the defendant what are we asking price wise. The defendant responded with she will take \$40 for sex and \$25 for a blow job which is street terminology for oral sex. At this time, [REDACTED] asked the defendant where he could get some "Hard" which is street terminology for crack cocaine. The defendant replied saying that they could get it at Burger King located at 231 N Dixie Hwy within the city of Lake Worth, Fl, 33460. Next, [REDACTED] and the defendant drove to a location just South of Burger King where [REDACTED] handed the defendant (2) \$10 dollar bills which he placed into the defendants right hand. The defendant proceeded to travel North to Burger King where members of the District 14 Street Team continue to have eyes on her travels. When the defendant got to the Burger King parking lot, she walked up to a Black male later identified as Andrea Thompkins whom was later arrest reference PBSO case#17-070448 and handed him the (2) \$10 dollar bills where Thompkins in return handed the defendant an unknown item in her left hand. Next, the defendant walked back South towards [REDACTED] not stopping to talk or make contact with anyone on the way. When she got back into the vehicle, the defendant handed [REDACTED] a small piece of what was later identified as .1 gram of Crack Cocaine which field tested positive.

A pre-determined signal was given where members of the District 14 Street Team conducted a traffic stop on [REDACTED] utilizing a unmarked PBSO vehicle in the area of 400 block of North Dixie Hwy. At this time, the defendant was placed into custody and handcuffed using PBSO issued handcuffs double locking and checking for proper fit. She was later transported to District 14 substation where she was processed and then later transported to the Palm Beach County Jail by [REDACTED]

Based on the above facts probable cause exists for the arrest of the defendant with Offer to Commit Prostitution FSS 796.07(2E) and Sale of Crack Cocaine FSS 893.13(1A1).
