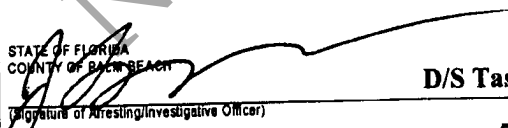

On 07/07/2019 at approximately 01:39hrs, while conducting selective traffic enforcement in the area of S State Road 7 and Forest Hill Blvd. which is located in the Village of Wellington, Palm Beach County, Florida I initiated a traffic stop on the defendant's vehicle, a 2018 Jeep Grand Cherokee, for reasonable suspicion of DUI. The defendant was swerving in far right lane of S State Road 7 nearly striking the curb. I observed the vehicle then attempt to correct her action, swerving to left three times causing several vehicles to slam on their brakes to avoid collision. The driver was identified as Erica Shari Feinman, by their Florida driver license. Feinman was the sole occupant of the vehicle. Upon making contact with the driver, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from her person and face area. This odor intensified as I spoke to Feinman. Feinman had glassy, glazed, and blood shot eyes. Feinmans's speech was slurred, slow, thick, and at times difficult to understand. Feinman's movements were (slow, deliberate, lethargic) with poor coordination. Feinman was wearing a white t-shirt, board short, and sandals. All the clothing appeared normal. PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 07/07/2019 at approximately 01:45hrs, I was called to the scene of a traffic stop near the intersection of South state Road 7 and Forest Hill Blvd, which is located in the Village of Wellington, Palm Beach County, Florida. I arrived at the scene at approximately 01:52hrs. D/S Jeffrey Taschner #6982 relayed to me, and completed a written signed sworn supplemental Probable Cause Affidavit, that he had stopped the defendant's vehicle, a 2018 Jeep Cherokee bearing FL tag HBG-D81, because the defendant failed to maintain a single lane swerving all the way to the right side of the roadway nearly striking the curb then abruptly cut back across to the left affecting traffic. D/S Taschner noticed that the defendant had articulable indicators of impairment, so he called for a DUI unit to conduct a possible DUI investigation. D/S Taschner identified the defendant, to me, as the driver and sole occupant of the vehicle, at the time of the stop.

OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by her Florida driver license as "ERICA SHARI FEINMAN", I immediately detected an obvious and strong odor of an unknown alcoholic beverage emanating from her person and face area. This odor intensified as I spoke to Feinman. *Feinman had extremely glassy, glazed, and blood shot eyes. Feinman's speech was slurred, thick, and at times difficult to understand and spoke quickly. Feinman's movements were slow and deliberate, and lethargic with poor coordination. Feinman was wearing a white t-shirt, print shorts, and brown sandals. All the clothing appeared somewhat neat.

DRIVER'S STATEMENTS:

Pre-Miranda: Feinman stated she had consumed an "Olde English" malt beverage.

Feinman refused to provide a breath sample after Implied Consent, which she stated she understood. Feinman declined to participate in the Q&A.

ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emanating from her person and face area which intensified as I spoke to Feinman.

GENERAL OBSERVATIONS

SPEECH: Feinman's speech was slurred, thick, and at times difficult to understand and spoke quickly.

ATTITUDE: indifferent, polite, friendly, cooperative

CLOTHING: Feinman's speech was slurred, thick, and at times difficult to understand but spoke quickly.

MEDICAL/OTHER: none stated

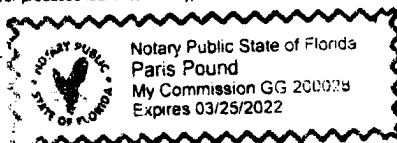

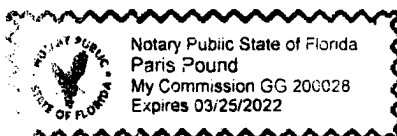
