


<p>On 09/22/2016 at approximately 1900 hours, I was dispatched to a suspicious vehicle in the area of Palmetto Park Road and Poweline Road, in unincorporated Boca Raton. The vehicle in question was a dark colored 2009 BMW 328I (bearing FL tag SKD10) and the complaint stated that the driver almost ran him off of the road.</p> <p>Upon arriving in the area I was able to locate the suspect vehicle on Palmetto Park Road and Aquila Street, in incorporated Boca Raton. The suspect, later identified as Erol Ozturk, was weaving through traffic and on several occasions performed traffic violations that put other drivers at risk. The vehicle was also registered to Ozturk. As both I and Ozturk drove westbound on Palmetto Park Road I witnessed the suspect perform an improper turn in the area of 10900 Palmetto Park Road, in unincorporated Boca Raton. As the suspect drove through a grass median to turn eastbound on Palmetto Park Road he nearly crashed with another vehicle.</p> <p>I then activated my overhead lights and initiated a traffic stop in the area of 9600 SW 3rd Street. Upon making contact with Ozturk, who was the driver of the vehicle, it was immediately apparent that he was under the influence of an unknown substance. As I spoke to Ozturk I was able to notice that his eyes were glassy red, his pupils were dilated, and he was sweating profusely. On several occasions Ozturk did not answer my questions directly and did not follow commands to keep his hands on his steering wheel. Based on Ozturk's condition I requested that Palm Beach County Fire rescue respond. Shortly thereafter PBCFR #51 responded to the scene and suggested to Ozturk that he be medically cleared at West Boca Hospital, to which he voluntarily gave consent for medical clearance (reference run number 16-980012). It should be noted as Ozturk spoke to the medical staff he volunteered that he had taken Heroin earlier in the day. I then inquired as to where Ozturk acquired the Heroin in which he explained from a black male that is approximately twenty years of age that lives in West Palm Beach, Florida. Ozturk stated that he has "ordered" from the subject approximately thirty (30) times. Ozturk also explained that he does not know the subjects name but that his telephone number is (561) 319-9075 and he always drives a dark colored Volkswagen Jetta.</p> <p>Based on Ozturk declining to have anyone else retrieve his vehicle from its current location Boca Raton City Towing was called to perform a tow. During a property inventory of Ozturk's vehicle I was able to locate a Dan Wesson .357 revolver hand gun which was loaded with 6 rounds of .357 ammo on the passenger side floor board encased in a black gun box. Thirty-two (32) additional rounds were also found in the glove box of the vehicle. Located in the center console of the vehicle was a small clear capsule which contained a brown substance inside. The substance was later field tested was a PBSO issued Narcotics Analysis Regent field test kit which received a positive result for the presence of opiates, the active ingredient in Heroin. The total package weight of the substance weighed out to .03 grams. It should be noted the substance was clear view after the center console was opened and there was also a second clear capsule that was empty next to the drug filled capsule.</p> <p>Based on the following investigation I believe that probable cause exists for Erol Ozturk for possession of a schedule I Narcotic pursuant to F.S.S. 893.13(1A1).</p>
