II. <u>DETAILS OF DUI/BUI</u>

A. Phase 1 - Initial Observation of vehicle/vessel in operation

On Saturday, May 25, 2019 at approximately 1900 hours, I, Officer James Brodbeck of the Florida Fish and Wildlife Conservation Commission, along with Officer Paul Godward, was on vessel patrol on the west side of Peanut Island. I observed a black PWC with no registration numbers operating on plane in the posted Slow Speed Zone with 3 persons on board. The operator of the vessel was identified as ESTEBAN RAMOS. Officer Godward activated the patrol vessel's emergency lights and sirens to initiate a vessel stop, however, RAMOS did not stop until reaching Jim Barry boat ramp.

B. Phase 2 - Personal Contact with driver/operator of vehicle/vessel

Upon making contact with the operator, I detected the odor of an alcoholic beverage emitting from his breath. His eyes were bloodshot, and he was slurring his speech. RAMOS was extremely sunburned.

C. Phase 3- Pre-arrest screening and Observations of Driver/Operator

HGN: During Horizontal Gaze Nystagmus, RAMOS displayed a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and an onset of nystagmus prior to 45 degrees in both eyes.

FTN: During Finger to Nose, Instruction Stage, RAMOS started at the wrong time. During the Performance Stage, RAMOS brought the right hand up without being given instructions to do so. On the first left, RAMOS did not use his fingertip, missed the tip of the nose, and did not bring the finger back down as instructed. On the first right, RAMOS hesitated, searched for the tip of the nose, ad did not bring the finger back down. On the second left, RAMOS did not use his fingertip

and did not bring his finger back down. On the second right, RAMOS did not use his fingertip and did not bring the finger back down. PP: During Palm Pat, the RAMOS had numerous chopped pats and did not increase speed after being instructed to speed up.

HC: During Hand Coordination, Instruction Stage, the subject began the task before being told to do so. During Task 2, RAMOS clapped his hands 4 times and did not bring his fists back together correctly. During Task 3, RAMOS did not bring his left fist to his chest.

D. Arrest of Driver/Operator

At 1911 I placed RAMOS under arrest for suspicion of BUI. At the Palm Beach County Jail, RAMOS refused to provide a breath sample after being read implied consent. I charged RAMOS with the following violations:

F.S. 327.35(1)- BUI Normal Faculties Impaired

F.S. 327.35215(1)- Refusal to submit to Submit to Breath Test pursuant to 327.352

Officer Godward issued citations for no registration numbers displayed and violation of the Slow Speed Zone.

E. Disposition of Driver and vehicle/vessel

I transported RAMS to the Palm Beach County Jail, Main Detention Center, arriving at 2000 hours. The vessel was turned over to the other occupant of the vessel (family member) at the request of RAMOS.

II. <u>DETAILS OF DUI/BUI</u>

A. Phase 1 - Initial Observation of vehicle/vessel in operation

On Saturday, May 25, 2019 at approximately 1900 hours, I, Officer James Brodbeck of the Florida Fish and Wildlife Conservation Commission, along with Officer Paul Godward, was on vessel patrol on the west side of Peanut Island. I observed a black PWC with no registration numbers operating on plane in the posted Slow Speed Zone with 3 persons on board. The operator of the vessel was identified as ESTEBAN RAMOS. Officer Godward activated the patrol vessel's emergency lights and sirens to initiate a vessel stop, however, RAMOS did not stop until reaching Jim Barry boat ramp.

B. Phase 2 - Personal Contact with driver/operator of vehicle/vessel

Upon making contact with the operator, I detected the odor of an alcoholic beverage emitting from his breath. His eyes were bloodshot, and he was slurring his speech. RAMOS was extremely sunburned. Based on the vessel in motion and my contact with the operator, I suspected possible

impairment and requested that RAMOS complete Standardized Seated Field Sobriety Tasks. RAMOS agreed to the tasks.

C. Phase 3- Pre-arrest screening and Observations of Driver/Operator

HGN: During Horizontal Gaze Nystagmus, RAMOS displayed a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and an onset of nystagmus prior to 45 degrees in both eyes.

FTN: During Finger to Nose, Instruction Stage, RAMOS started at the wrong time. During the Performance Stage, RAMOS brought the right hand up without being given instructions to do so. On the first left, RAMOS did not use his fingertip, missed the tip of the nose, and did not bring the finger back down as instructed. On the first right, RAMOS hesitated, searched for the tip of the nose, and did not bring the finger back down. On the second left, RAMOS did not use his fingertip and did not bring his finger back down. On the second right, RAMOS did not use his fingertip and did not bring the finger back down. On the third right, RAMOS did not use his fingertip and did not bring his finger back down. On the third left, RAMOS did not use his fingertip and did not bring his finger back down.

PP: During Palm Pat, the RAMOS had numerous chopped pats and did not increase speed after being instructed to speed up.

HC: During Hand Coordination, Instruction Stage, the subject began the task before being told to do so. During Task 2, RAMOS clapped his hands 4 times and did not bring his fists back together correctly (right fist was closest to chest). During Task 3, RAMOS did not bring his left fist to his chest.

Officer Godward issued citations for no registration numbers displayed and violation of the Slow Speed Zone.


E. <u>Disposition of Driver and vehicle/vessel</u>
