PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
PFC Counts advised me he observed a white 2015 Nissan Altima bearing NY tag # HAP3777 fail to come to a complete stop while exiting the parking lot at 5500 Military Trl. to turn north on S Central Blvd. PFC Counts also advised that the vehicle also ran a stop sign inside the aforementioned plaza. PFC Counts advised he followed the vehicle as it traveled north on S Central Blvd. and stated that the vehicle was traveling for approximately one mile straddling the dotted lane divider while traveling north on S Central Blvd. PFC Counts also advised he observed the vehicle activate its left turn signal in the area of S Central Blvd. and W Frederick Small Rd. but turn right, traveling east on W Frederick Small Rd. PFC Counts advised he conducted a traffic stop on the vehicle and identified the driver by his NY driver license to be Evan Lash (w/m; 02/26/2989). PFC Counts advised when he made contact with Lash, he noted that Lash was slurring his speech and was traveling in the complete opposite direction of his alleged destination (see supplement from PFC Counts).

OBSERVATION OF DRIVER:

I observed Lash was wearing a blue sweatshirt and jeans when I approached the vehicle. When I asked Lash why he had been pulled over, he began slurring his speech while speaking with me. I observed that Lash had bloodshot, glassy eyes and noted the faint odor of an unknown alcoholic beverage coming from the vehicle. I asked Lash to exit the vehicle and spoke with him outside the car. I noted the odor of an unknown alcoholic beverage coming from Lash, which intensified as he spoke. After my initial contact with Lash, I began moving my vehicle to a safe location in order to conduct roadside tasks. As I moved my vehicle, Officer Connor was watching Lash. Officer Connor advised me that he observed Lash take a drink out of cup inside the vehicle and then throw the contents of the cup outside the vehicle, which ended up all over Officer Connor. When Officer Connor approached me, I could smell the odor of alcohol which appeared to be coming from the liquid thrown out of the vehicle by Lash on Officer Connor's arms.

DRIVER'S STATEMENTS:

Lash originally advised that he was coming from McDonald's when I made contact with him. Lash denied drinking earlier in the evening and advised he was attempting to drive his friend home to his residence off Main St. It should be noted that the direction Lash was observed driving by PFC Counts was taking him further away from his destination. After exiting the vehicle, Lash advised that approximately one hour prior to my contact with him, he consumed 2 cocktails at Jumby Bay (Bar in Abacoa).

ODORS:

Odor of unknown alcoholic beverage which intensified as he spoke.



Other Observations:

During the exercise, Lash would anticipate the location of the stimulus while checking for lack of smooth pursuit. Lash had to be reminded to keep his head still and follow the stimulus with his eyes. Lash was also reminded to keep his eyes on the stimulus, as he would snap his eyes back and look straight ahead while checking for Distinct and Sustained Nystagmus at Maximum Deviation.

WALK & TURN

While demonstrating the starting position to Lash, it appeared as if he was having difficulty following instructions as he had to be instructed several times to place his foot on the line and was having trouble placing his left foot on the line. Lash also had difficulty placing his right foot in front of his left with the heel of his right foot touching the toe of his left and stood with his right foot approximately halfway in front of his left foot standing almost with his feet together. After being instructed to stay in the starting position and not move during the Instruction Stage, Lash was unable to stand in the heel-to-toe position and placed his right foot off the line to steady himself twice. Lash missed heel-to-toe on steps 1, 2, 3, 5, and 9. Lash stepped off the line, to the left, on steps 1, 3, and 9. Lash stepped off the line, to the right on steps 2 and 6. Lash failed to turn in the manner described and demonstrated to him and turned by taking one large step with his front foot to turn around. Lash missed heel-to-toe on steps 1, 2, 3, 5, 6, and 9. Lash stepped off the line, to the left, on step 1. Lash stepped off the line, to the right, on step 8. At intermittent times during the exercise, Lash quickly raised his arm(s) more than 6 inches from his waist to steady himself several times.

ONE LEG STAND:

Lash raised his right leg off the ground and failed to keep his foot pointed out on his elevated leg, as instructed. On the count of "1007," Lash used his arms for balance and put his foot on the ground. Lash raised his right foot off the ground and began counting from where he left off, as instructed. On the count of "1014," Lash raised his arms more than 6 inches from his side and appeared to lose his balance, to the rear, as he took a step backwards with his right foot. In a timed 30 second period, Lash only counted to 1018.

FINGER TO NOSE:

On the first call of "left," Lash touched the tip of his left finger to his septum and did not return his arm to his side. Lash had to be reminded to place his arm down by his side before continuing. On the first call of "right," Lash touched the tip of his right finger to his upper lip, below his nose. On the second call of "left," Lash again touched the tip of his left finger to his septum. On the second call of "right," Lash touched the pad of his right finger to the tip of his nose. On the third call of "right," Lash touched the side of his right finger to the tip of his nose. On the third call of "left," Lash touched the pad of his left finger to the tip of his nose.

ROMBERG ALPHABET:

Lash recited the following letters of the alphabet (spaces indicate brief pauses): "ABCDEFGH IJKLMNOP QRX XYZ" Lash grouped the letters L, M, N, O, and P together and appeared to slur each letter together, saying the group relatively quickly, compared to how he was reciting the other letters previously.





Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.
