On Monday June 25, 2018 while on routine patrol in the parking lot of 102 N. Fed Hwy in the City of Lake Worth, I observed a black Chevy Camaro 2 Dr bearing FL tag IXLX21 drive East bound on a West bound only roadway (Lucerne Ave). While traveling in the wrong direction, several vehicles passed on the opposite direction, honking at the driver to turn around. The vehicle then continued over the Lake Worth bridge, still on the wrong side of the road. I conducted a traffic stop and met with the driver, Amber Sterling W/F DOB 06/26/1996 (Identified by FL DL). I informed Sterling for the reason of the traffic stop. Sterling advised she was not aware that she was driving the wrong way, did not see the vehicles that drove past her or hear them as they honked the horn at her. Sterling also stated that she was not from Lake Worth and was not familiar with the one way street but later stated that she visits Lake Worth routinely.

While speaking with Sterling her speech was slurred and her eyes were glassy. Due to these signs of impairment, Investigator Schaefer 8777, was notified and reported to the scene to conduct a DUI investigation.

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 06/25/2018 at approximately 02:52hrs, I was called to the scene of a traffic stop in the 400 block of Lake Worth Road, which is on the Lake Worth Bridge, located in the City of Lake Worth, Palm Beach County, Florida. I arrived at the scene at approximately 03:07hrs. D/S Marcelo Carrera #31809 relayed to me, and completed a written signed sworn supplemental Probable Cause Affidavit, that he had stopped the defendant's vehicle, a black 2014 Chevy Camaro SS bearing FL tag IXL-X21, because the defendant was driving on the wrong side of the roadway traveling eastbound on the bridge in the westbound lanes. D/S M. Carrera noticed that the defendant had articulable indicators of impairment, so he called for a DUI unit to conduct a possible DUI investigation. D/S M. Carrera identified the defendant, to me, as the driver of the vehicle, at the time of the stop.

### OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by her Florida driver license as "FALLON AMBER STERLING", I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from her person and face area. This odor intensified as I spoke to Sterling. She had glassy, glazed, and blood shot eyes. Sterling's speech was slightly slurred and slow. Sterling's movements were deliberate and over exaggerated. Sterling had difficulty following directions given to her. Sterling was wearing a pink tank top, gray yoga pants, and sandals. All the clothing appeared neat.

### DRIVER'S STATEMENTS:

Pre-Miranda: Sterling at first stated she did not drink anything but later changed her story that she was drinking. Sterling felt the need to add the comment, "But not that much".

Sterling refused breath after Implied Consent, which she stated that she understood. sterling participated in the Q&A where she admitted post Miranda that she had a couple of Strawberry Daiquiris.

### ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from her person and face area which intensified as I spoke to Sterling.

## GENERAL OBSERVATIONS

SPEECH: Sterling's speech was slightly slurred and slow.

ATTITUDE: indifferent, cooperative, becoming annoyed and resistive

CLOTHING: pink tank top, gray yoga pants, and sandals.



**Other Observations:**

Sterling would sway roughly in a side to side front to back pattern throughout the task. Sterling did touch the tip of the pen as directed to positively identify the point to be tracked. She was reminded numerous times to track the pen with her eyes only. She failed to keep her head still while tracking the stimulus. Sterling had VGN and LOC was not detected.

**WALK & TURN:**

I explained and demonstrated the instructions for the "Walk & Turn" to Sterling who stated the she understood. During the task, I observed her to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Sterling could not maintain her balance while listening to instructions. She stepped out of the instructional stance during the demonstration to catch her balance. Sterling started the task before being instructed to do so. Sterling would pause her steps to regain balance. She missed heel-to-toe steps and stepped off the line. Sterling performed the turn other than which was demonstrated.

**ONE LEG STAND:**

I explained and demonstrated the instructions for the "One Leg Stand" to Sterling who stated that she understood. During the task, I observed her to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Sterling continued to sway while balancing on one leg. She failed to count properly by thousands as instructed.

**FINGER TO NOSE:**

I explained and demonstrated the instructions for the "Finger to Nose" task to Sterling who stated that she understood. During the task, I observed Sterling to sway roughly in a side to side, front to back pattern throughout the demonstration phase. She failed to return her arms down to her sides as instructed after touching her nose. Sterling's index finger did not touch the tip of the nose on all 6 of 6 attempts. She searched for the tip of her nose using the finger to find their nose prior to touching the tip. On L1, L2, L3 she touched the right nostril and on R1, R2, and R3 she touched the left nostril. The sequence used for this task was L, R, L, R, R, L.

**ROMBERG ALPHABET:**

I explained and demonstrated the instructions for the "Rhombert Alphabet" task to Sterling who stated that he understood. During the task, I observed her to sway roughly in a side to side, front to back pattern throughout the demonstration phase. She would sway more than 2 inches. Sterling correctly recited the alphabet.
