

	<p>boyfriend, Farris Shatara for several days now and she has been trying to get him to leave her residence. She advised that she and Shatara are in a relationship and have been living together since February 2016. She came home tonight and he was outside the apartment and ran up to her vehicle and began beating on her windows. She advised that Shatara was questioning her as to where she had been and with who. She started to drive around the circle toward the exit of the development. When she reached the stop sign at Central Gardens Way and Central Gardens Circle, Shatara drove the opposite direction and tried to block her from turning. Another vehicle was turning onto Central Gardens Way and Shatara flashed his lights for the vehicle to turn. As Crissman began to turn left to exit the development, Shatara backed his Ford F150 into the driver's door of her Audi causing damage to her vehicle. Crissman drove toward the exit on Central Boulevard and when she stopped for traffic, Shatara pulled up beside her and started banging on her vehicle. She had her cell phone in her hand and Shatara grabbed her phone from her and would not give it back. She was scared because he was in such a rage so she left south on Central Boulevard. She advised he pulled out behind her and was driving beside her trying to run her off the roadway. Crissman advised that she pulled into Old Palm Country Club and stopped at the gate and asked the security officers to call 911 because she was afraid for her safety and she no longer had a cell phone because her boyfriend took it. At that time, Shatara pulled into the security gate and exited his vehicle and began yelling at Crissman. Lieutenant Stewart (Security) responded to the area and advised that due to the aggressive tone Shatara had, he asked him to step away from the area. At that time, Shatara advised Lieutenant Stewart that he and his girlfriend were having an argument and she drove into his vehicle. He advised he followed her from the residence to the gate. During the time Lieutenant Stewart was speaking with Shatara he noticed the smell of an unknown alcoholic beverage coming from his person. Stewart then asked Shatara to leave the property to diffuse the situation and security officers directed Crissman inside the gate for safety and contacted this agency.</p> <p>While obtaining Crissman's statement, security advised that Shatara had returned to the property. Crissman advised that Shatara is known to carry a Glock firearm in his vehicle. While officers were enroute to the gate entrance, Shatara exited his vehicle, and walked to the gate where he was met by Sgt. Hawkins, Ofc. Koegel #456 and I. He was ordered to the ground and detained for further investigation. Post Miranda, Shatara advised that he and his girlfriend had an argument and she ran into the back of his vehicle. He advised that he followed her to this location to make sure that she was okay. When I asked him if he knew where her phone was he replied it was in his bag in his truck. I asked how the phone got there and he said he took it from her because she wanted to look at his phone so he wanted to look at her phone, however, he was in possession of both of their phones. He advised that she was cheating on him and he was upset and over reacted to the situation. At another point during questioning, Shatara advised that he backed into her vehicle because the bed of the truck is long. Shatara also advised that he and Crissman have been in a relationship and living together since February 2016.</p> <p>Security Officer Trent Ackleson gave a statement on body worn camera to Ofc. Johnston #451 and advised that he was the security officer at the gate when both vehicles came onto the property. He advised that Crissman asked for help and was visibly shaking and upset. He advised that Shatara exited his vehicle and went up to Crissman's vehicle and put his hands on her car and began yelling at her. He requested assistance from other security officers and they allowed Crissman to enter inside the gate to keep her safe. At that time, Shatara told Ackleson that Crissman was going to "pay the price".</p> <p>Security Officer Alvarado gave a sworn statement indicating that he observed a male subject, identified as Shatara screaming at a female identified as Crissman. He advised the Lieutenant separated the individuals and they escorted the female inside the gate on their property. The male subject "warned" the female to "watch</p>



