I responded to Townplace Suites Marriott, 2450 Quantum Blvd, Boynton Beach, FL in reference to an unwanted guest.

BPPD Communications (Dispatch) advised a white female wearing a black leather jacket was in the lobby refusing to leave and threatening to kill the staff members.


Upon arrival I observed a white female matching the description later identified as W/F Felise Slinger (DOB 9/24/66) sitting in the lobby of the above hotel. I then made contact with the caller and front desk receptionist B/F Jashala Wester (DOB 5/28/90) identified by FL/DL. Wester advised Slinger checked out of the hotel earlier at approximately 1314 hours and left. Slinger then returned to the hotel under the influence of an unknown alcoholic beverage trying to go back to the room she checked out of. Slinger told Wester she still had stuff in the room and was not leaving and going to kill someone if she didn't get her stuff. Wester advised Slinger did not leave any items in the room because the cleaning crew would have notified her if there was, and new guests are now occupying the room. Wester advised she wanted Slinger to leave because she was causing a disturbance and threatening employees.

I then made contact with Slinger who advised she did check out of the hotel earlier but left items inside the room. While speaking with Slinger I detected the odor of an unknown alcoholic beverage emitting from her breath; which intensified as Slinger spoke. I also observed Slinger's speech was thick and slurred and her eyes were bloodshot/glassy. While speaking with Slinger she began shouting at the staff and was creating a public disturbance, at one point she stood up went up to the front desk and started shouting at Wester. Let it be known other guests were in the lobby while she was causing a disturbance. While speaking with Slinger she admitted to being intoxicated stating "I can't drive I'm drunk". Slinger also later advised "I didn't do anything all I did was get drunk". Officers explained to Slinger that she needed to leave the property for the night because she was intoxicated and causing a disturbance. Officers also explained that she could come back in the morning and speak with the daytime staff who checked her out, about her missing items. Officers offered to call Slinger a cab so she could go to her parents' house or assist her with ordering an Uber. Slinger advised she was not leaving the property.

Employee Wester then verbally trespassed Slinger in my presence for a year from the property at which time Slinger advised she understood. Officers also explained to Slinger if she continued to stay on the property she would be subject to arrest. Slinger still refused to leave stating multiple times "just arrest me, I'm not leaving". Slinger eventually ordered a Uber, however when the Uber arrived Slinger again stated she is not leaving. Slinger then demanded and screaming at officers to "go get my fucking shit".

At this point I then asked Slinger to stand up so officers could place her into handcuffs. Slinger refused and stated "No, you're not going to arrest me". Officers again asked Slinger to stand up multiple times which she continued to refuse. I then grabbed Slingers right arm while officer Pires (996) grabbed Slingers left arm and assisted her up. While trying to place Slinger into cuffs she began tensing her arms up, pulling away and refusing to comply with verbal commands. I asked Slinger numerous times to stop resisting which she did not comply.

Based on the aforementioned facts, I find probable cause to charge Felise Slinger with one count of Trespass after warning pursuant to F.S.S 810.08(1), and one count of resisting arrest without violence pursuant to F.S.S 843.02. Based on my observations and Slinger's public display of disorderly intoxication as witnessed by several people to include Jashala Wester, I also find probable cause to charge Felise Slinger with one count of Disorderly Intoxication pursuant to F.S.S 856.011.
