On above date and time I responded to [REDACTED] which is located in the PLANTATION MOBILE HOMES ESTATES, unincorporated West Palm Beach Florida, in ref to a domestic dispute. Upon my arrival I met with the complainant/victim H/F Ana Galvez. Ana had a contusion above her left eye, laceration to her right ear, right cheek, and scratches on her right knee and right elbow. Ana refused EMS or medical treatment. Ana was crying and very emotional.

Ana stated that that her boyfriend, H/M FELIX ROLDAN CORTES, who lives with her at the above mentioned residence, came home drunk last night from work. At approximately 0500 hours Felix started arguing with Ana in the kitchen. In a fit of rage Felix started punching Ana in the face and pushed her down to the ground. Ana was able to get away from Felix. Felix, who was highly intoxicated, went to sleep in the back bedroom. Ana then got her six year old daughter, Ana Sofia Roldan, and left the residence. Ana Sofia did not witness the incident. Ana completed a sworn written statement, which was later placed into evidence. DART D/S Campbell I.D. 28980 responded to the incident location and took several photos of Ana and her various injuries.

I then met with Felix, who was sleeping in the rear bedroom. Felix was highly intoxicated as he had slurred speech, glassy bloodshot glassy eyes, and was unsteady on his feet. Felix spontaneous uttered "I got a little crazy, but I don't remember hitting her." Felix requested an attorney before answering any investigative questions. Felix had no injuries.

After conducting my investigation and speaking with all parties involved, I determined that the DEF. FELIX ROLDAN CORTES, did in fact unlawfully strike the victim, Ana Galvez, against her will, which is a violation of F.S.S. 784.03. (1) a 1 (simple battery). Felix was placed in handcuffs, which were double locked and checked for proper fit. Felix was transported to the PBC jail for booking and processing. This case is cleared by arrest.
