PROBABLE CAUSE

On December 11th, 2017 at approximately 10:20 AM I observed a 4 Door Honda sport Utility vehicle blue in color bearing Florida Tag 456QHE traveling westbound on SR-704 east of Oakton Preserve Way in the outside center lane at a high rate of speed. The vehicle passed me while speeding and I obtained a clock of on the vehicle of 65 mph in a posted 50 mph zone. I activated my blue lights and the vehicle pulled onto Oakton Preserve Way and stopped behind the Mattisyn School which is next to the Renaissance Charter School. While the vehicle was stopping the driver the lone occupant kept reaching down as if to conceal something in the center console area. I made contact with the driver and he was visibly nervous (shaking and stumbling over his words and stuttering as he talked). The driver gave verbal consent to search the vehicle and mentioned there maybe a firearm in the vehicle. Upon searching the vehicle I discovered a cigarette box in the center console storage containing 2 capsules of what appeared to possibly be heroin. The driver when I walked back to my Patrol vehicle with the cigarette box advised it was Heroin. A field test confirmed it was fentanyl and not heroin. The driver was read Miranda and advised he understood. The driver was ID as Forrest Saxon Morelli with a DOB of 10/13/1993 by a Florida Driver's License. Mr. Morelli advised post miranda that the car was his girlfriends car. He further advised that he just bought 3 capsules and had taken one prior to the stop. Mr. Morelli advised the 2 capsules I found in the cigarette box were his. He further advised that he had purchased them from a black male driving a black BMW in the parking lot of the gas station at the southeast corner of Haverhill Road and 45th St. Mr. Morelli was arrested for possession of a controlled substance. When I put Mr. Morelli in the back of my patrol car he began to fall asleep while talking to him. I brought him out of the car to be able to see him better and he continued to fall asleep while standing and talking. Mr. Morelli's right eye started to move independently of his left eye and then his eyes started to roll up. I asked FHP Dispatch to dispatch Fire Rescue reference a possible overdose at this point. Mr. Morelli then advised me he was not feeling well and that he needed to puke. At this point Mr. Morelli walked over to the grass and began to puke. He also started to sweat extremely at this point and I had him take a seat on the curb. I had to keep Mr. Morelli from falling asleep/passing out. Just as Fire Rescue arrived Mr. Morelli passed out and Fire Rescue to over treatment. Mr. Morelli was transported to JFK North Hospital in reference to the overdose. Mr. Morelli was charged with the following charges:
 Possession of a controlled substance without a prescription in violation of F.S.S. 893.13(6)a
 Keeping/Public nuisance in a motor vehicle for drug activity in violation of F.S.S. 823.10(1)
 Possession of a controlled substance while in physical control of a motor vehicle in violation of F.S.S. 893.13(1)(a)(1)
 Mr. Morelli was transported to the Palm Beach County Jail upon his release from the Hospital.
 Evidence turned into the FHP Evidence.


